SECOND AMENDMENT TO PROFESSIONAL SERVICE CONTRACT BETWEEN BERRYMAN & HENIGAR, INC. AND CITY OF REDLANDS FOR PLAN CHECK AND INSPECTION SERVICES

RECITALS
