UTILITIES AGREEMENT NO. 5948

Date -----

FIRST PARTY: State of California, acting by and through its Department of Transportation, hereinafter called STATE.

SECOND PARTY: CITY OF REDLANDS

hereinafter called OWNER.

- I. Relocation is required of certain utility facilities of OWNER, cost of which is to be borne by STATE because: Of the Company's prior rights as established on Grant Deed dated December 18, 1931, recorded December 31, 1931, in Book 779, Page 157, Official Records of San Bernardino County.
- II. In accordance with Notice to Relocate No. 5948 dated July 18, 1975, Owner shall furnish and install approximately 725 feet of 8-inch steel pipe right of Engineer's Station 344+90 to 351+00 centerline of improvement. All work shall be performed substantially in accordance with Owner's plan consisting of three sheets and attached to letter dated July 30, 1975, copies of which are on file in the District Office of the Department of Transportation, 247 West Third Street, San Bernardino, California. Minor deviations from the above-described work may be made and incidental work performed by the Owner when mutually acceptable to both parties and upon approval by the State.
- III. Owner agrees to cause the herein described work to be performed by a contract with the lowest qualified bidder, selected pursuant to a valid competitive bidding procedure, and to furnish or cause to be furnished all necessary labor, materials, tools, and equipment required therefor, and to prosecute said work diligently to completion.
- IV. The State shall pay its share of the actual cost of said relocation within 90 days after receipt of an itemized bill in quintuplicate, signed by a responsible official of Owner's organization, compiled on the basis of the actual cost and expense. The Owner shall maintain records of the actual costs incurred and charged or allocated to the project in accordance with recognized accounting principles.

It is understood and agreed that the State will not pay for any betterment or increase in capacity of Owner's facilities and that Owner shall give credit to the State for all accrued depreciation on the replaced facilities and for the salvage value of any material or parts salvaged and retained or sold by Owner.

- V. Owner's records shall be made available to State auditors for verification of bills presented.

Estimated Cost to STATE \$ 36,350.00

OWNER agrees to perform and STATE agrees to pay for the above-described work in accordance with the terms of this Agreement.
