1. Reasonable precautions will be exercised to avoid damage and protect persons or property.
2. PERMITTOR assumes no liability for loss or damage to property or injuries to or deaths of agents, contractors, or employees of PERMITTEE by reason of the exercise of privileges given under this permit.
3. Nothing in this permit shall preclude PERMITTOR from filing a claim(s) with the State Victim Compensation and Government Claims Board for any loss or expense which PERMITTOR or its tenant may suffer caused by or due to exercise by PERMITTEE of the rights granted by this permit.
4. PERMITTEE agrees to indemnify and hold PERMITTOR harmless from any damage caused by PERMITTEE's activities authorized by this permit. PERMITTEE agrees also to either reimburse PERMITTOR for any damage to PERMITTOR's roads and fences, or other property, occurring by reason of the exercise of rights granted herein, or to replace or restore said property.
5. PERMITTEE will notify PERMITTOR at least 48 hours prior to entry onto the property.
