- COMPLIANCE WITH PUBLIC CONTRACTS LAW: OWNER is a public agency in the State of California and is subject to the provisions of law relating to public contracts. It is agreed that all provisions of law applicable to public contracts are a part of this contract to the same extent (5)

as though set forth herein and will be complied with by CONTRACTOR.
