Approve a lease agreement with the City of Redlands for a nutrition center for seniors at 111 W. Lugonia Avenue, Redlands.

BACKGROUND: On April 6, 1995, the Community Services Department requested that Real Estate Services Department negotiate a five-year lease agreement with the City of Redlands for a nutrition program for senior citizens in the Redlands area.
