

RESOLUTION NO. 6528

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDLANDS PROVIDING FOR THE ASSESSMENT OF COSTS RESULTING FROM THE ABATEMENT OF WEEDS, WHICH CONSTITUTE A FIRE HAZARD

WHEREAS, Chapter 8.40, Section 080, of the Redlands Municipal Code, "Abatement of Weeds and Rubbish", requires that material constituting a fire hazard be declared a public nuisance and removed, and the Code further provides that if an owner shall fail to remove or abate the material determined to be a public nuisance, the Fire Chief or his authorized representative shall cause such nuisance to be abated, with costs to be assessed against the property; and

WHEREAS, the Fire Department of the City of Redlands, the agency responsible for the administration of Chapter 8.40 of the Redlands Municipal Code, did notify the owners of record of such properties in compliance with Section 080 of said Code, that such material has been determined to be a public nuisance and abatement was necessary; and

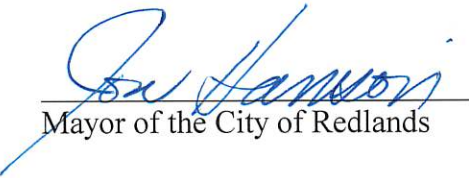
WHEREAS, the owners of record as shown on the last available assessment roll failed to take action to abate the nuisance on their properties as itemized in Exhibit A, attached hereto; and

WHEREAS, the Fire Department did order the abatement work done by private contractor and submitted a demand for payment, in addition to a service charge of \$197.00 to each owner of property, by mail, these accounts remaining unreimbursed; and

WHEREAS, the City Council has considered the reports and accounts as itemized in Exhibit A, together with any objections or protests by interested parties;

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF REDLANDS approves the reports and accounts as shown in Exhibit A for submittal to the Auditor of San Bernardino County, who will record and enter the assessments on the roll against the properties as itemized in Exhibit A.
