

RESOLUTION NO. 5508

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDLANDS AMENDING RESOLUTION NO. 5504 RELATIVE TO AN APPLICATION TO THE LOCAL AGENCY FORMATION COMMISSION TO INITIATE PROCEEDINGS FOR ANNEXATION OF CERTAIN INHABITED TERRITORY (ANNEXATION NO. 76)

WHEREAS, the City Council of the City of Redlands has adopted Resolution No. 5504 which declared its intention to initiate proceedings with the San Bernardino Local Agency Formation Commission (LAFCO) to annex certain inhabited lands located within the City's Sphere of Influence; and

WHEREAS, the City of Redlands has since received requests from numerous owners of property located in the unincorporated area in the City's Sphere of Influence, commonly known as the "donut hole," to include their properties within the City's pending annexation request; and

WHEREAS, after consultation with staff of LAFCO, this City Council is informed that the City may accommodate the wishes of such additional property owners and include those properties within the City's pending annexation proceedings by amending Resolution No. 5504;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF REDLANDS AS FOLLOWS:

Section 1. That the City Council of the City of Redlands, for the reasons hereinafter mentioned, has filed an application with LAFCO to initiate proceedings to annex to the City of Redlands certain territory hereinafter described, as inhabited territory, pursuant to the Cortese-Knox Local Government Reorganization Act of 1985, Division 3, commencing with Section 56000 of the Government Code of the State of California.

Section 2. That the City Council's reasons for initiating the annexation proceedings are as follows: The annexation of the hereinafter described territory will contribute to the orderly growth of the City, provide the proper control of street layout, drainage and sanitary sewer design, and insure the proper use of land in conformity with the overall plan of the City.

Section 3. That this proposal is consistent with the City's General Plan governing the Sphere of Influence of the City of Redlands.

Section 4. That Resolution No. 5504 is hereby amended by the adoption of this Resolution.

Section 5. That the territory which the City Council proposes to annex is hereby identified as Annexation No. 76 and consists of all that real property situated in the County of San Bernardino, State of California, described in Exhibit "A," attached hereto, and as shown on the maps attached

hereto as Exhibit "B."

Section 6. That the City Clerk of the City of Redlands is hereby directed to file with LAFCO of the County of San Bernardino, State of California, a copy of this resolution amending the proceedings which have been initiated to annex territory to the City of Redlands, to request a report by the Commission provided for by the Cortese-Knox Local Government Reorganization Act of 1985, and to submit and execute such other applications and reports as may be required by law in such annexation proceedings.

All of Lots 1 through 15, Block 3 of Mentone Stretch Map, recorded in Book 8 of Maps, Page 81; portions of the southeast quarter of the southwest quarter of Section 19, T1S, R2W, SBBM; all of Tract No. 12224 recorded in Book 196 of Maps, Pages 75 and 76, as amended by map recorded in Book 206 of Maps, Pages 22 and 23; all of Tract No. 13504 recorded in Book 206 of Map, Pages 84 and 85; all of Tract No. 12913 recorded in Book 206 of Map, Pages 49 and 50; all of Tract No. 13489 recorded in Book 206 of Map, Pages 51 and 52; Blocks 73 and 82 of Mentone Townsite, recorded in Book 6 of Maps, Page 35; all of Lot 3 and a portion of Lot 4, Block 30 of Crafton Tract recorded in Book 3 of Maps, Page 14; Lot 1 and a portion of Lot 2 of the Resubdivision of Lots 1, 2, 3, 4, 5 and 6 of Block 1 of the Judson Subdivision of Lot 39, recorded on Book 17 of maps, Page 26, and portions of Lots 40, 41 and 42, of Block 77 of Rancho San Bernardino, recorded in Book 7 of Maps, Page 2, all are records of San Bernardino County in the State of California, being described as follows:

Commencing at a point on the northwest corner of Section 30, T1S, R2W, SBBM, as shown in Record of Survey, Book 28, Pages 80 and 81, being accepted as the intersection of the centerline of Colton Avenue and the northerly prolongation of the easterly right-of-way line of Wabash Avenue, said easterly right-of-way line being the existing city limit line of the City of Redlands, as shown in Parcel Map 13887 recorded in Map Book 164, Pages 18 and 19 in San Bernardino County, State of California, said point being the point of beginning;

Thence northerly along the westerly section line of said Section 19, last said line also being the centerline of Wabash Avenue and the existing city limit line of the City of Redlands, to its intersection with the centerline of Nice Avenue;

Thence easterly along the centerline of Nice Avenue to the intersection of the centerline of Olivine Avenue;

Thence northerly along the centerline of Olivine Avenue to the intersection of the centerline of Florence Avenue (vacated), last said line being the north line of said Blocks 73 and 82, of Mentone Townsite;

Thence southerly along last said easterly line to the southwest corner of Parcel 1 as shown in Parcel Map No. 5388, recorded in Book 52 , Page 99 records of said County;

Thence easterly along the southerly line said Parcel Map No. 5388 and prolongation thereof, to the centerline of Crafton Avenue;

Thence southerly along the centerline of Crafton Avenue to the intersection of the centerline of Colton Avenue;

Thence westerly along the centerline of Colton Avenue to the northerly prolongation of the easterly line of Lot 2, Block 7 of said Crafton Tract, said point being the northwest corner of the easterly one-half of the northeast quarter of the northeast quarter of said Section 30;

Thence southerly along said easterly line of Lot 2 of Block 7 of the Crafton Tract, recorded in Book 3 of Maps, Page 14, of said County and State, to the southerly line of said Lot 2;

Thence westerly along the southerly line of said Lot 2 to the centerline of King Street;

Thence southerly along the centerline of King Street to a point being 687.85 feet south of the northerly line of said Section 30 (the centerline of Colton Avenue);

Commencing at a point at the intersection of the centerline of Sixth Avenue and the centerline of Wabash Avenue, said centerline also being the existing city limit line of the City of Redlands, and said point being the point of beginning;

Thence easterly along the centerline of Sixth Avenue to the intersection with the northerly prolongation of the east line of Lot 2, Block 27 of the Crafton Tract;

Thence southerly along last said east line to the southeast corner of said Lot 2;

Portions of Section 16, 17, 20 and 21, T1S, R3W, SBBM; more particularly described as follows:

Following the various courses of the existing Redlands city limits, beginning at the intersection of the west boundary line of the City of Redlands as originally incorporated, said line also being the intersection of the north and south quarter section line of Section 21, T1S, R3W, SBBM, with the east and west quarter section line of said Section 21;

Thence westerly along the east and west quarter section line of said Section 21 and continuing along the east and west quarter section line of Section 20, T1S, R3W, SBBM, to its intersection with the southerly prolongation of the east line of Lots 6 and 3 of Block 6, of the Henry L. Williams Tract, as recorded in Book 11, Page 17 in the office of the County Recorder, County of San Bernardino, State of California;

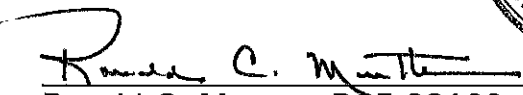

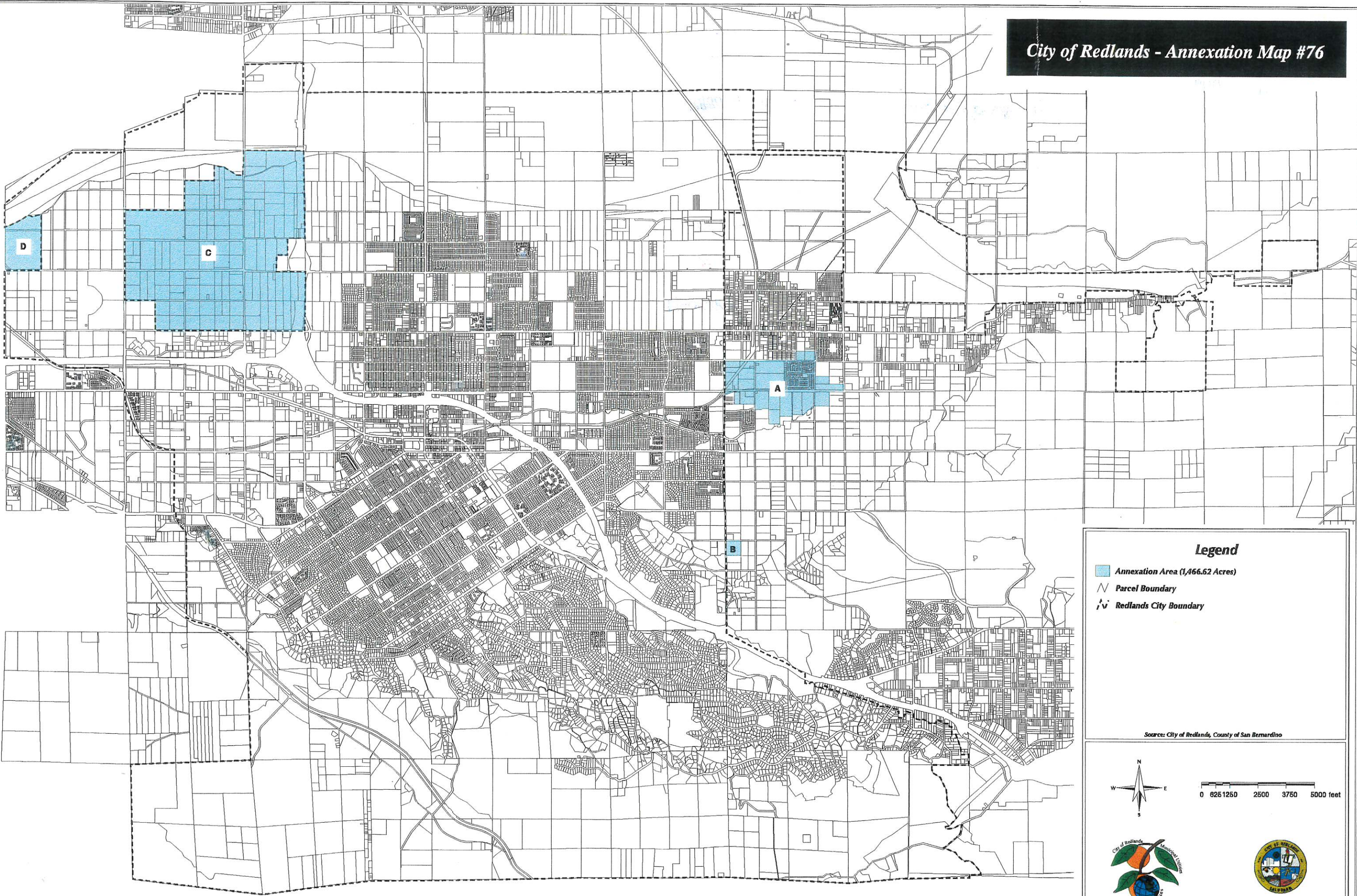

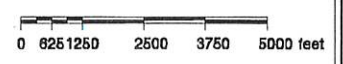
City of Redlands - Annexation Map #76



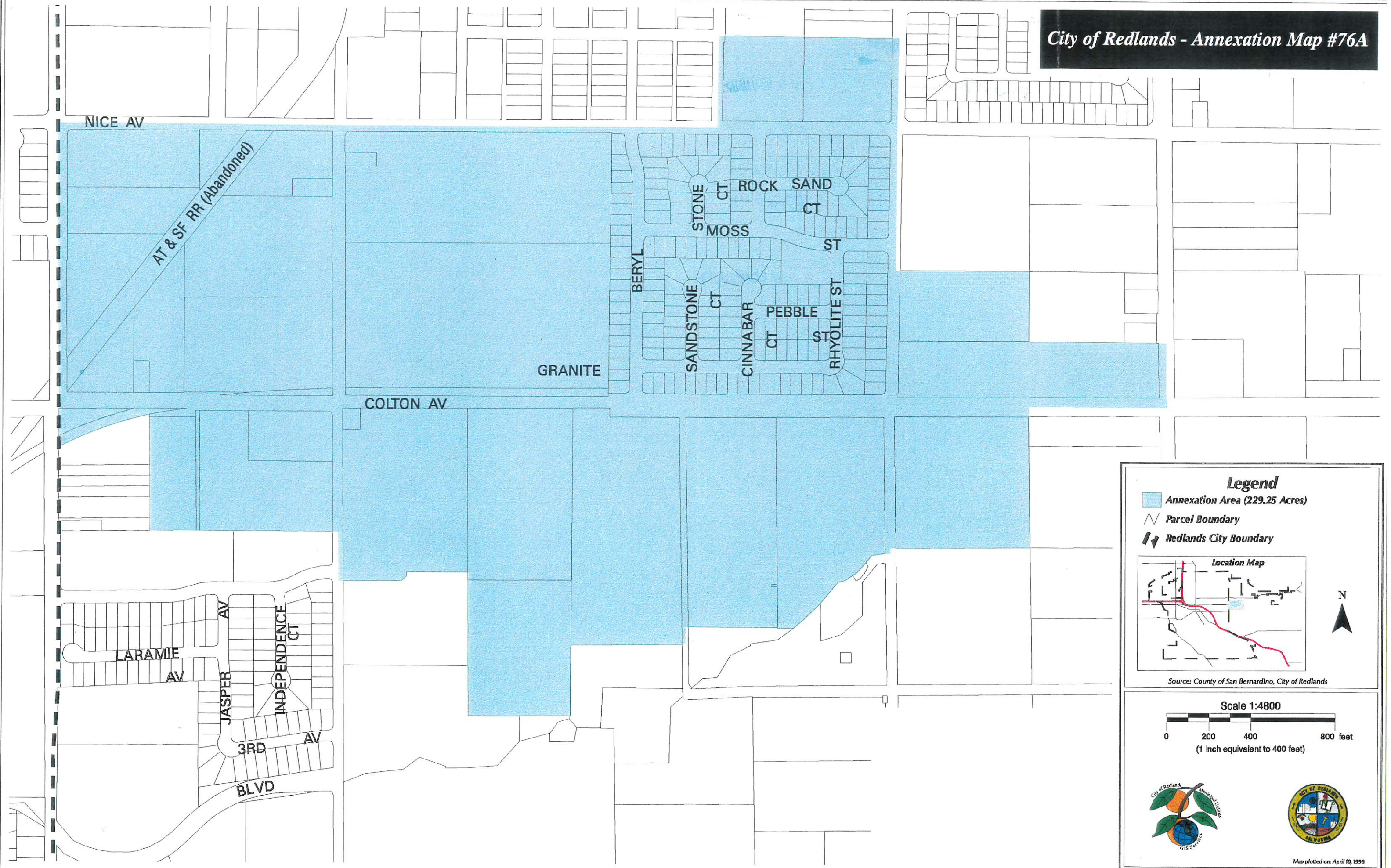

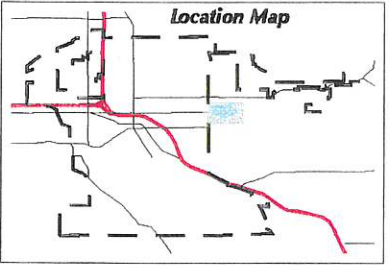


City of Redlands - Annexation Map #76A



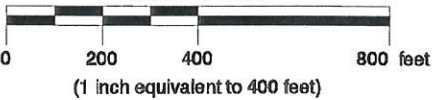

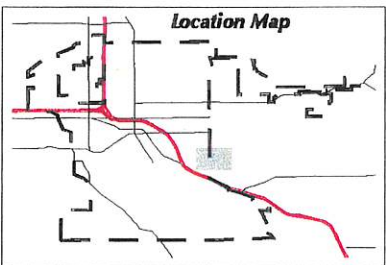

City of Redlands - Annexation Map #76B



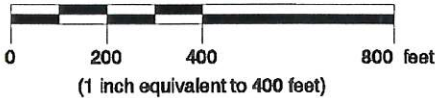

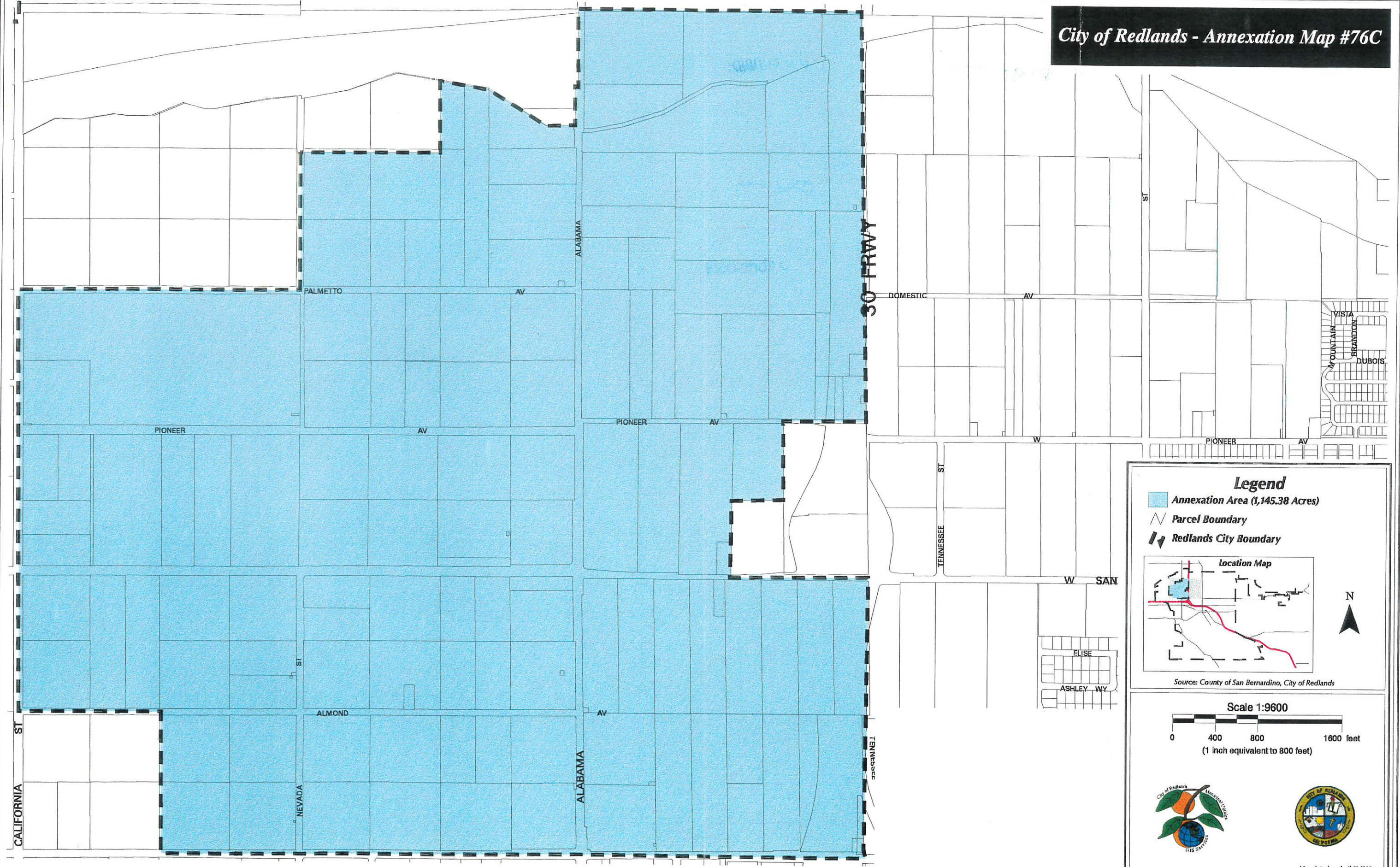

City of Redlands - Annexation Map #76C



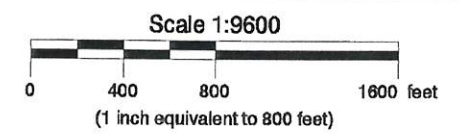

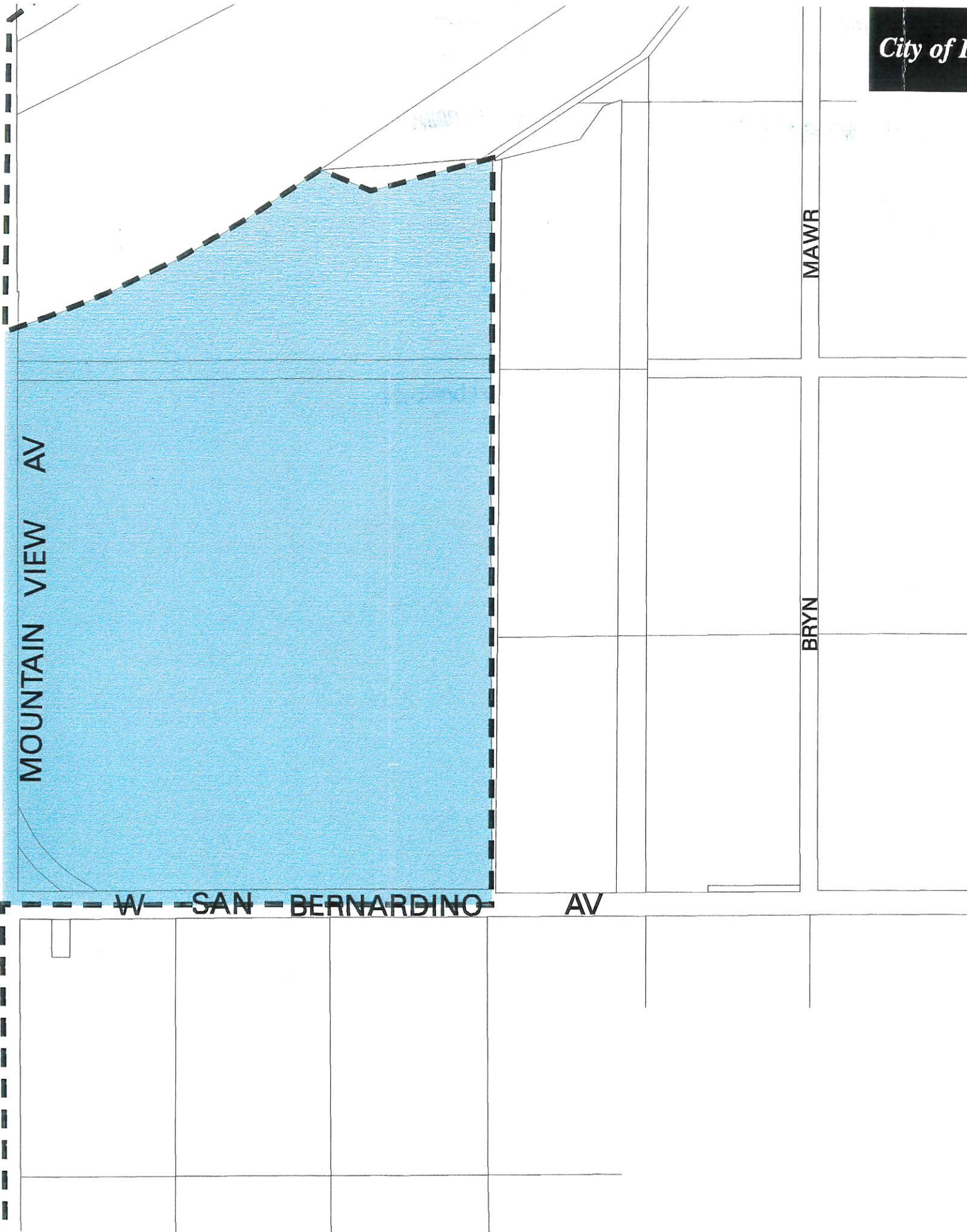

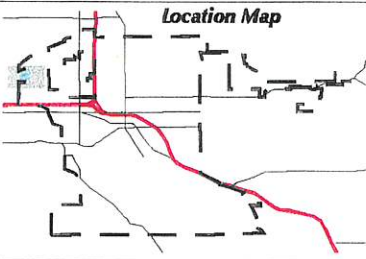
