- 1. Any defect in or lies or encumbrance on the title to the estate or interest covered hereby in the land described or referred to in Schedule C, existing at the date hereof not shown or referred to in Schedule B or excluded from coverage in Schedule B or in the Combitions and Supulations, or
- 2. Unmarketability of such title, or
- Any defect in the execution of any murigage shown in Schidule B securing an indebtedness, the owner of which is named as an Insured in Schedule A, but only insular as such defect affects the lien or charge of said mortgage upon the estate or interest referred to in this policy, or
- 4. Priority over said mortgage, at the date hercot, of any hen or encumbrance not shown or referred to in Schedule B, or excluded from coverage in the Conditions and Supulations, said moregage being shown in Schedule B in the order of its priority;

all subject, however, to the provisions of Schedules A. B and C and to the Conditions and Supulations nereto annexed.

- 3. Easements, claims of easement or encumbrances which are not shown by the public records.
- 4. Discrepancies, conflicts in boundary lines, shortage in area, encroachments, or any other facts which a correct survey would disclose, and which are not shown by the public records.
- 5. Unpatented mining claims; reservations or exceptions in patents or in Acts authorizing the issuance thereof; water rights, claims or title to water.

- 5. An unlocated easement over said land for pipe lines and incidental purposes as reserved by Redlands Street Railway Company, in deed recorded March 7, 1903 in book 332 page 161 of Deeds.

SCHEDULE C

The land referred to in this policy is described as follows:

All that portion of lot 2, Denman's Subdivision, in the county of San Bernardino, state of California, as per map recorded in book 15 page 23 of Maps, in the office of the county recorder of said county, and portion of the northwest 1/4 of Section 1, Township 2 south, Range 3 west, San Bernardino meridian, according to government survey, described as a whole as follows:

COMMENCING at the center line intersection of Mariposa Drive, (30.00 feet wide), and Rossmont Drive (30.00 feet wide); thence South 85° 02' 00" West, 175.00 feet, along said center line of Mariposa Drive; thence North 04° 58' 00" West, 15.00 feet, to the northerly right of way line of said Mariposa Drive and the true point of beginning; thence North 85° 02' 00" East, 160.00 feet along said north line to the westerly line of said Rossmont Drive; thence North 02° 37' 30" West, 132.00 feet, along said westerly line to the southerly right of way line of Garden Street (60.00 feet wide). Thence along the said southerly right of way, North 58° 18' 00" West, 198.00 feet, thence Southerly 249.00 feet to the true point of beginning.
