AGREEMENT TO PURCHASE TAX DEEDED LAND

- 1. That as provided by Section 3800 of the Revenue and Taxation Code, the cost of giving notice of this agreement shall be paid for by the San Bernardino County Flood Control District.
- 2. That the Board of Supervisors of the County of San Bernardino agrees to sell to said San Bernardino County Flood Control District and said San Bernardino County Flood Control District agrees to purchase from said County the property hereinafter set out in th
