Term: The effective date of this agreement is April 26, 2000. This agreement shall terminate on April 1, 2004.

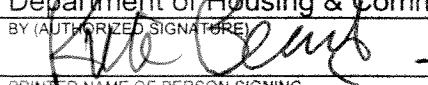
All other terms and conditions remain as set forth in the original agreement and amendments thereto.
