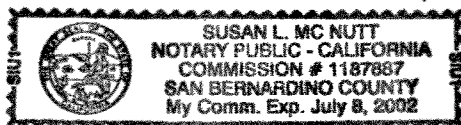

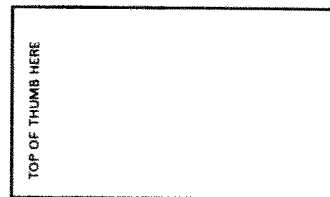

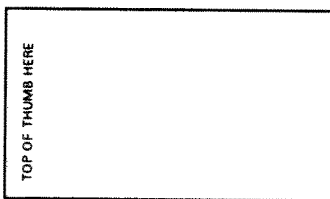

EXHIBIT "A"

The East 11 feet of the following described real property:

A portion of the Southeast quarter of Section 22, Township 1 South, Range 3 West, San Bernardino Base and Meridian, according to the United States Government Township Plat approved by The Surveyor General, September 4, 1858, in the City of Redlands, County of San Bernardino, State of California, described as follows:

Beginning at a point in the center line of Church Street which is South a distance of 310.00 feet from the Northeast corner of said Southeast quarter of Section 22, said Northeast corner lying on the center line intersection of Church Street and Lugonia Avenue;

thence West parallel with the North line of the said Southeast quarter a distance of 33.00 feet to the TRUE POINT OF BEGINNING;

thence from the TRUE POINT OF BEGINNING West parallel with the North line of the said Southeast quarter a distance of 407.00 feet;

thence South parallel with center line of Church Street a distance of 290.00 feet;

thence East parallel with the North line of the said Southeast quarter a distance of 407.00 feet;

thence North parallel with the center line of Church Street a distance of 290.00 feet to the TRUE POINT OF BEGINNING.
