LEGAL DESCRIPTION EASEMENT ACQUISITION, PARCEL T

REAL PROPERTY IN THE CITY OF REDLANDS, COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA, DESCRIBED AS FOLLOWS:

THAT PORTION OF THE WEST ONE HALF OF THE NORTH ONE HALF OF BLOCK (OR LOT) 19 OF THE BARTON RANCH, AS PER PLAT RECORDED IN BOOK 6 OF MAPS, PAGE 19 RECORDS OF SAID COUNTY, DESCRIBED AS FOLLOWS:

COMMENCING AT THE INTERSECTION OF THE EAST LINE OF ALABAMA STREET AND THE SOUTH LINE OF COLTON AVENUE AS SAID STREET AND AVENUE ARE SHOWN ON SAID MAP; THENCE SOUTH 01°00'10" EAST, 9.95 FEET ALONG SAID EAST LINE OF ALABAMA STREET TO A POINT ON THE SOUTHERLY RIGHT OF WAY LINE OF REDLANDS BOULEVARD FORMERLY CALIFORNIA STATE HIGHWAY NO. 99; THENCE CONTINUING ALONG SAID EAST LINE OF ALABAMA STREET, SOUTH 1°00'10" EAST, 250 FEET; THENCE PARALLEL WITH SAID SOUTH LINE OF COLTON AVENUE, NORTH 89°35'20" EAST, 300.00 FEET TO THE TRUE POINT OF BEGINNING; THENCE PARALLEL WITH SAID EAST LINE OF ALABAMA STREET, NORTH 01°00'10" WEST, 222.98 FEET. MORE OR LESS TO A POINT ON SAID SOUTHERLY RIGHT OF WAY LINE OF SAID REDLANDS BOULEVARD, SAID POINT LYING ON A CURVE CONCAVE TO THE SOUTH, WHOSE RADIUS IS 2750 FEET AND WHOSE INITIAL TANGENT BEARS SOUTH 82°07'47" EAST; THENCE ALONG SAID CURVE SOUTHEASTERLY 280 FEET THROUGH A CENTRAL ANGLE OF 05°50'01"; THENCE PARALLEL TO SAID EAST LINE OF ALABAMA STREET, SOUTH 01°00'10" EAST, 222.98 FEET; THENCE NORTH 79°12'45" WEST, 279.88 FEET TO THE TRUE POINT OF BEGINNING.

SAID LAND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE MOST NORTHERLY POINT OF THE HEREINBEFORE DESCRIBED LAND; THENCE SOUTHEASTERLY ALONG THE SAID SOUTHERLY LINE OF REDLANDS BOULEVARD, BEING A CURVE CONCAVE SOUTHWESTERLY, HAVING A RADIUS OF 2750.00 FEET, THROUGH A CENTRAL ANGLE OF 03°54'11" AND AN ARC LENGTH OF 187.34 FEET TO THE TRUE POINT OF BEGINNING; THENCE CONTINUING ALONG THE ARC OF SAID CURVE, THROUGH A CENTRAL ANGLE OF 01°55'50" AND AN ARC LENGTH OF 92.66 FEET, TO THE EASTERLY LINE OF THE HEREINBEFORE DESCRIBED LAND, (THE INITIAL RADIAL LINE BEARS NORTH 11°46'24" EAST); THENCE SOUTH 01°00'10" EAST ALONG SAID EASTERLY LINE, A DISTANCE OF 5.10 FEET, TO THE BEGINNING OF A NON-TANGENT CURVE


