JOINT MEETING - REDEVELOPMENT AGENCY AND CITY COUNCIL

<u>Hotel Presentation</u> - Mr. Harrison introduced William Swank, Sr., SDC, LLC, a hotel developer, and David Wilensky, Regional Director of Franchise Sales and Development for Six Continents who presented information about a prototype Holiday Inn they are considering for downtown Redlands. The hotel would be six stories high and have 143 rooms, an indoor pool, restaurant, small bar and a meeting room for 150 people. They indicated they would be delighted to participate with the City in conserving precious land for parking and would be willing to design the hotel with a "Redlands look and feel." Ms. Kim thanked Board Members and staff for their assistance and concluded her presentation by encouraging the students to attend this event.
