The meeting was opened with the pledge of allegiance, followed with the invocation by Reverend Don Woodstock of the Church of Christ Christian.

The minutes of the regular meeting of August 3, 1965, were approved with the following additions:

Mr. Hartzell: Planning Commission Recommendations, page two, last line to read: "It perpetuates a non-conforming use <u>following a cessation</u> of a period of approximately two years of that use."

Mr. Cummings: Planning Commission Recommendations, page one, line 34, to read: "then existing Ordinance No. 1202, as a problem parcel due to its shape, the adjacent railroad tracks and the flood hazard."

Mr. Merritt: Resolution No. 2470 to read: "A resolution of the City of Redlands providing for a raise of 10% in charges made for disposal department services brought about by the increase in rates charged at the County dump site." - page three.

Mr. Merritt: Resolution No. 2469 to read (line 3): "as applies to the Park Department - authorizing the addition of a 'Park General Foreman,'"

lution No. 2465 - Annexation No. 25 - Mayor Burroughs at this time declared the meeting open as a public hearing of any protests or comment relative to the proposed annexation. None being forthcoming, the public hearing was closed, and Councilman Cummings made the following motion: "This City Council having met on the 17th day of August, 1965, in the Safety Building of the City of Redlands, at the day, hour and

lic hearing was closed, and Councilman Cummings made the following motion: "This City Council having met on the 17th day of August, 1965, in the Safety Building of the City of Redlands, at the day, hour and place fixed in Resolution No. 2465 for hearing of protests to proposed Annexation No. 25, and no protests having been made, I move that this City Council does resolve and determine that protests have not been made by the owners of one-half of the value of the territory proposed to be annexed as shown by the last equalized assessment roll, nor by public and private owners of one-half of the value of the territory proposed to be annexed as determined by said legislative body; and that the proposed annexation shall be initiated by a duly adopted ordinance." Motion seconded by Councilman Wagner and adopted.

Ordinance No. 1299 Ordinance No. 1299, an ordinance of the City of Redlands approving Annexation District No. 25, was introduced and the title read by Attorney Taylor and laid over under the rules with second reading scheduled for September 7, 1965.

Ordinance No. 1297 Fire Zones Ordinance No. 1297, an Ordinance amending Ordinance No. 1218 entitled, "An Ordinance Creating and Establishing Fire Zones in the City of Redlands," was scheduled for public hearing at this time. Mayor Burroughs again declared the meeting open as a public hearing for the purpose of hearing any protests or comment. None being forthcoming, the public hearing was declared closed. Ordinance No. 1297 was adopted on motion of Councilman Wagner, seconded by Councilman Cummings, with the following roll call vote:

ORIENTED SIGNS, thereto be approved. On motion of Councilman Hartzell, seconded by Councilman Cummings, R.P.C. No. 251 was approved by the Council, and Ordinance No. 1301, an ordinance of the City of Redlands, amending Redlands Ordinance Code, Chapter 81, by addition of Section 8111.20 - Regulations for Freeway Oriented Signs - thereto, was introduced and laid over with second reading scheduled for September 7, 1965.

ADVISORY COMMITTEE RECOMMENDATIONS as considered by the City Council at a regular meeting thereof held August 17, 1965.

That the request of Mr. M. K. Feenstra for permission to sign 1. the improvement ordinance agreement in lieu of the installation of sidewalks as required in Commission Review and Approval No. 185 as per Ordinance 1000 for property known as 1705 and 1705 West Colton Avenue, which was first considered at the Council meeting of August 3, 1965, be reconsidered in view of additional findings. Following discussion of the seven-inch step-down into the building which would develop if the sidewalks are installed in front of the pizza parlor - such step-down or ramp not being permitted in the building code - the Council relunctantly approved the recommendation of the Advisory Committee that an agreement be signed and that sidewalks be installed in the future as soon as physically possible, on motion of Councilman Wagner, seconded by Councilman Hartzell.

Following the business meeting, the Council was addressed by Mr. Neil Pfulb, San Bernardino County Director of Planning, who discussed the East Valley General Planning Study which includes the City of Redlands and is part of the General Master Plan of the County.

The Council expressed support of the program as a whole, encouraged the continuation of the study, and offered help in the sections of the study pertaining to Redlands.

COMMUNICATIONS

Mayor Burroughs read a letter from the Southern California Association of Governments' Formation Committee (SCAG) requesting the appointment of a representative and an alternate to represent Redlands on this committee. Mayor Burroughs was appointed as representative and Councilman Wagner to serve as alternate.

UNFINISHED BUSINESS At the Council meeting of August 3rd, the Chamber of Commerce presented the Council with a request for additional funds from the City. This matter was tabled until this meeting in order to allow further study by representatives of the Council together with members of the Chamber. At this time, following discussion by the Council and representatives of the Chamber of Commerce, Councilman Hartzell proposed the following motion: "I move

- 3) The amounts stated shall be disbursed from Unappropriated General Fund Budget Surplus.
- 4) This appropriation applies to the current fiscal year only and is in no sense a commitment upon future City budgets."

This motion was seconded by Councilman Cummings and adopted by the City Council.

Ordinance No. 1300 Ambulance Franchise Ordinance No. 1300, an ordinance of the City of Redlands granting a franchise to operate authorized emergency ambulance service within the City of Redlands to Leroy C. Gish, presented, second detailed reading waived on motion of Councilman Hartzell, seconded by Councilman Wagner, and adopted by the following vote:

CITY MANAGER

Review of Storm Damage Before proceeding with the agenda items, City Manager Merritt presented a resume of the conditions within the City as a result of the severe storm on August 11, 1965. He expressed appreciation for the City employees' willing and cooperative efforts during the storm and in the ensuing clean-up program; reviewed the damage to City property and equipment; pointed out the needs for an accelerated flood control program for the City and a grading ordinance for the County to prevent drainage damage into the City, and stressed the problem of people dumping trash into the drainage system.

Following discussion, on motion of Councilman Hartzell, seconded by Councilman Wagner, Mayor Burroughs was authorized to direct a letter to the County Board of Supervisors requesting the adoption of a County Grading Ordinance.

Manager Merritt presented a request for additional appropriations for salary and transportation for the new position of Park **Depart**—ment General Foreman. On motion of Councilman Cummings, seconded by Councilman Wagner, \$2,700.00 for truck and radio and \$5,733.00 for salary — both sums to be financed from the Park Fund Budget Surplus, were approved by the City Council.

R.I.D.C.

Recommendations regarding industrial development were received from the Redlands Industrial Development Council. The City Council expressed appreciation and accepts the recommendations for further study.

On motion of Councilman Cummings, seconded by Councilman Hartzell, the recommendations of the Recreation Commission regarding Floral Plunge were accepted, and special note made of the fourth paragraph made - to hold Floral Plunge until an appropriate facility is provided.

Resolution No. 2471 Resolution No. 2471, a resolution of the City of Redlands approving a Grant Deed from the City to the San Bernardino Flood Control District in connection with construction at the Morrey Arroyo, presented and adopted on motion of Councilman Wagner, seconded by Councilman Cummings.

Resolution No. 2472, a resolution of the City of Redlands fixing the rate and levying the property tax for the fiscal year 1965-66 at

Resolution No. 2472 Tax Rate 1965-66 \$1.88 per \$100.00 of assessed valuation was submitted for Council consideration and adopted on motion of Councilman Hartzell, seconded by Councilman Cummings. Mayor Burroughs pointed out that the financial condition of the City was stable as a result of good management and departmental economies and that the .03 increase in the levy was necessary for the expanded recreational program now in progress throughout the City.

The annual report of the A. K. Smiley Library was received and the annual report of the Park Department.

Lease Offer Old City Yards The council received a lease-option offer for the old City Yard property at Texas and Oriental Streets in the amount of \$190.00 per month for the first year with option to purchase at the end of one year, at the meeting of August 3, 1965. At this time, the offer comes as a straight lease at the same price with option to renew for one year.

City Manager Merritt presented a staff study of the cost of bringing the property up to standard, and following lengthy discussion, the offer was rejected on motion of Councilman Hartzell, seconded by Councilman Cummings. Motion carried. Councilman Wagner voted "No" for the reason that he believes it is not good business for the City to allow property to lie dormant when it has a potential of income.

Easement from Theos and Haskins An easement from Alexander Theos and Roy G. Haskins to the City to erect and operate a rotating beacon on property which is adjacent to the Municipal Airport runway and just west of the Fixed Base operation hangar, accepted on motion of Councilman Wagner, seconded by Councilman, Hartzell, with the City Manager authorized to execute the certificate of acceptance on behalf of the City.

Bills and salaries were ordered paid as approved by the Finance Committee.

No further business demanding attention at this time, on motion, the Council adjourned at 10:00 P.M.
