PROCLAMATION

Acting City Clerk Jenny Kruse read a proclamation declaring May 24-30, 1976, as American Field Service Week. The proclamation briefly described the history of the International Scholarship Program and urged all citizens to support the quality of brotherhood and citizens to support the quality of brotherhood and understanding between all people, and to respond generously to the solicitations of the Redlands Chapter to help provide international scholarships.

The Council concurred in issuing this proclamation over the signature of the Mayor.

UNFINISHED BUSINESS

Acting City Clerk Jenny Kruse described Resolution No. 3232, a resolution of the City Council of the City of Redlands, urging the United States Postal Service to approve the postmark "Inland Empire" for Redlands mail processed through the San Bernardino Sectional Center. This resolution was originally proposed by the City of Riverside and has been before Council previously.

Acting Assistant to the City Manager Rob Anderson briefly described the goals and objectives of the Redlands Juvenile Task Force which is a functioning body of concerned citizens assisting community youths and has requested Council support. This organization is under the guidance of the Redlands-Yucaipa Guidance Clinic, the YMCA, the Police Department, and the Recreation Department. Following a brief discussion, on motion of Councilman Miller, seconded by Councilman Elliott, the Council unanimously concurred in recognition of this worthy group.

COMMUNICATIONS

Mayor DeMirjyn announced a Health Care meeting on April 8, 1976, at Citrus Village. The League of California Cities program for new mayors and councilmen will be held April 21-23, 1976. The Citrus Belt dinner will be held in Corona on March 24, 1976, and Mayor DeMirjyn asked which Councilmembers would be attending; Councilwoman Grace so indicated. The Mayor urged all to attend.

Acting City Manager Chuck Willhite presented Resolution No. 3240, a resolution of the City Council of the City of Redlands, of intention to approve an amendment to the contract between the Board of Administration of Public Employees Retirement System and the City Council. The purpose of this amendment is to change the benefits, retirement age, and contributions for local safety members. The motion of Councilman Elliott, seconded by Councilman Miller, to adopt Resolution No. 3240 was superseded by Councilman Knudsen stating that the matter had not had sufficient study, and moving to table Resolution No. 3240. His motion was seconded by Councilwoman Grace and adopted by the following roll call vote:

Parking

Acting City Librarian, Molly Van Diest brought a request from the library that the parking lot on Eureka Street directly across from the library be posted "Library and Bowl Use Only." Miss Van Diest explained that the lot is used entirely by postal employees who arrive early in the morning and cause library users and library employees to use the street parking. The matter was discussed at length. It was pointed out by Acting City Attorney Anne DiMaria that the only manner of control for this parking area would be to post it for two-hour parking. Following considerable discussion, on motion of Councilwoman Grace, seconded by Councilman Miller, unanimous approval was given to posting the lot with a sign reading "Two-Hour Parking Between 9:00 A.M. and 5:00 P.M."

Acting Street director Loretta Lengerich presented a corporation quitclaim deed from the City of Redlands to Florence R. Brown and William H. Brown. This parcel was originally used for the street lighting system on Harding Drive which has been reconstructed and the easement is no longer needed. On motion of Councilman Miller, seconded by Councilman Elliott, unanimous approval was given to the release of this property and the Mayor and City Clerk were authorized to execute the agreement.

Acting Utilities Superintendent Karen Wilson presented a grant of easement from the City of Redlands to the Southern California Edison Company for the relocated electrical system necessitated by the construction of Highland Avenue Reservoir at Ford Park. Following explanation, on motion of Councilman Miller, seconded by Councilman Elliott, the grant of easement was unanimously approved, and the Mayor and City Clerk authorized to sign in behalf of the City.
