of an adjourned regular meeting of the City Council, City of Redlands, held in the University of Redlands' Alumni House, 1200 East Colton Avenue, on December 29, 1983, at 9:00 A.M.

The purpose of this adjourned regular meeting of the City Council was to meet in an informal atmosphere during which time discussion could be held on several items and goals could be set. Also present were: Mike Reynolds, City Treasurer; Robert Brickley, Police Chief; Ray Mills, Fire Chief; W. C. Schindler, Planning and Community Development Administrator; John Donnelly, Public Works Director; H. L. Archbold, Finance Director; Linda Kirwan, Assistant Finance Director; Robert Dale, Building and Safety Director; Phyllis Irshay, Smiley Library Director; Harold Moore Sanitation Director; Larry Taylor and Larry Egan, members of the Redlands Professional Fire Fighters; and a representative from the League of Women Voters. Three people from the general public were present after lunch. Also present was Derrill Quaschnick, RDA Director.

Council discussed the following topics during the seven-hour retreat: revenue/expenditure picture; analysis of City charges for services; establishing a Finance Committee; priorities; procedure for appointments to boards and commissions; Emergency Preparedness Plan and the establishment of a community disaster council; annexations; establishment of a Redlands Centennial Committee; organizing a picnic to honor City employees on March 11, 1984; legislative priorities; and the location of a new fire station.

Council requested that ordinances pertaining to commissions and boards be reviewed and that ordinances be drafted to regulate the Joslyn Senior Center Advisory Board, the Community Center Advisory Board, and the Rent Review Board.

Summarizing the discussions, Council set the following as top priorities for 1984:

1. Annexation of the areas south of Colton Avenue and Crafton Avenue including the East Sunset Drive loop, the Redlands Boulevard Corridor to California Street and Barton Road, and the "doughnut hole" area to the northwest.
2. Implementation of Phase I of the Redevelopment Project with a goal to locate a major retail business as an anchor and a performing arts center.

- 3. Emergency Preparedness Plan and the Community Council.
- 4. Commission/board appointments.
- 5. Location of new fire station.

The meeting was adjourned at 4:00 P.M.
