The meeting was opened with the pledge of allegiance followed by an invocation by Mayor Beswick.

Proclamation

Minutes of the regular meeting of March 18, 1986, and the adjourned regular meeting of March 21, 1986, were approved as submitted.

Bills and salaries were ordered paid as approved by the Finance Committee.

PLANNING AND COMMUNITY DEVELOPMENT

Residential Development Allocation No. 80-13A

Councilmember DeMirjyn moved to approve the transfer of RDA No. 80-13A from M. L. Mayor Beswick declared the meeting open as a public hearing for any questions or comments concerning this change of zone. None being forthcoming, the public hearing was declared closed.

In response to Glen Noyes' inquiry, City Attorney Holmes explained vesting of tentative maps. Bob Pierce suggested a master plan be implemented to be used in conjunction with the City's General Plan. Ordinance No. 1919, an ordinance of the City of Redlands adding Article 925 to Chapter 92 of Division 9 of the City of Redlands Ordinance Code relating to vesting tentative maps was given its first reading of the title by City Clerk Poyzer, and on motion of Councilmember Larsen, seconded by Councilmember DeMirjyn, further reading of the ordinance text was unanimously waived. Planning Commission Referral Councilmember Wormser reported she had met with the Planning Commission last Friday at Griswolds and that the Planning Commission will continue to meet on the fourth Friday of each month for purposes of a study session. HR-3838 Tax Reform Bill Councilmember Larsen moved to direct Mayor Beswick to contact our representative and prepare a letter of support for HR-3838, the tax reform bill. Motion seconded by Councilmember Wormser and carried unanimously.

Resolution No. 4158

School Mitigation

Councilmember Wormser expressed concern that there was no maximum amount established in Resolution No. 4157 on the amount of the school mitigation fee for multi-family dwelling units. Councilmember DeMirjyn reiterated his objections to the fees established by this resolution. Following discussion, on motion of Councilmember Wormser, seconded by Councilmember Johnson, Resolution No. 4158, a resolution of the City of Redlands requiring mitigation of school impaction caused by residential development and repealing Resolution No. 4157, and including the following in Section Six: "Amount of Fee. Any mitigation fee imposed by the School District will not exceed the amounts of \$2.20 per square foot of living space provided that multi-family dwelling units shall pay no less than \$1,600.00 per unit and no more than \$2,900.00 per unit, and provided further that single family residences shall pay no less than \$2,400.00 per dwelling unit and no more than \$3,960.00 per dwelling unit. Such fees shall be paid prior to the issuance of the final building permit authorizing construction of residential units, but may be paid at an earlier time," was adopted by the following vote:

The Southern California Water Committee, Inc. has scheduled a City Sector Organizational Meeting for Wednesday, April 9, 1986, at 9:30 A.M. in the Red Lion Inn, Ontario. Councilmember DeMirjyn will attend this meeting on behalf of the City.

Irrigation Companies Policy

On motion of Councilmember Larsen, seconded by Councilmember Wormser, Council unanimously established a policy that the City Council nominate the Utilities Engineer to serve on the Board of Directors of various irrigation companies, and in irrigation companies where the City owns sufficient stock to entitle it to two members on the Board of Directors, the second nominee for Director shall be a Councilmember.

Nomination Redlands Water Company Councilmember Beswick moved to nominate Public Works Director Donnelly and Councilmember Wormser as an alternate to serve on the Redlands Water Company Board of Directors. Motion seconded by Councilmember Larsen and carried unanimously.

Easements Grant Deed On motion of Councilmember DeMirjyn, seconded by Councilmember Johnson, Council unanimously authorized execution by the Mayor and City Clerk of easements and a Corporation Grant Deed to San Bernardino Valley Municipal Water District for Phase III Greenspot Pipeline and Booster Station construction.

Hydraulic Study

Councilmember DeMirjyn moved to authorize a hydraulic study of the Tate effluent line (high line) to determine the effect of replacing approximately 3,500 feet of main from Ward Way to Amethyst in Mentone or the addition of a booster station in the existing line. Motion seconded by Councilmember Johnson and carried unanimously.

Concessions

Redlands Bow1

Councilmember DeMirjyn moved that Reality Rock Ministries be permitted to sell concessions during a concert at the Redlands Bowl on June 6, 1986, and be exempted from the City's business license requirements under Section 2122 of the Redlands Ordinance Code. Motion seconded by Councilmember Johnson and carried unanimously.

Claim

The claim of Greg Dabov in the amount of \$50,000.00 was unanimously found not to be a proper charge against the City and therefore rejected on motion of Councilmember DeMirjyn, seconded by Councilmember Johnson.

Bid Call Tate

On motion of Councilmember DeMirjyn, seconded by Councilmember Johnson, a call for bids was unanimously approved for the construction of a sludge pond, recycling Treatment Plant station, and 190,000 gallon reservoir at the Henry Tate Treatment Plant.

Lease

A lease with Mentone Little League, Inc. for their use as open space and recreational facilities acreage on the east side of Amthyst and north of Mentone Boulevard was unanimously approved and the Mayor authorized to sign on behalf of the City on motion of Councilmember DeMirjyn, seconded by Councilmember Johnson.

There being no further business, the meeting adjourned at 8:15 P.M.
