Building Permits - Chief Building Official Nick Anderson reported there has been a total of 147 building permits issued for new residential units in 1990. This leaves 253 building permits still available for issuance for residential units in 1990. Staff recommended 44 permits be set aside for vested projects and that 128 permits be allocated for non-vested projects on July 1, 1990. This would leave 81 permits available for single family homes for the remaining six months of 1990. Councilmember Larson moved to approve the issuance of 128 building permits on July 1, 1990, pursuant to the Redlands Municipal Code Section 19.24.030 as recommended by staff. Motion seconded by Councilmember Beswick and carried by the following vote:

Resolution No. 4671 - Sewer Tax - On motion of Councilmember Beswick, seconded by Councilmember Larson, Resolution No. 4671, a resolution of the City Council levying the property tax for fiscal year 1990-91 for servicing the annual principal and interest of the 1962 sewer bonds, was adopted by the following vote:
