Proclamation

Acting Director of Public Works Nagan Ha Ngo accepted a proclamation recognizing April 6 and 7, 1991, as April Airport Days to help acquaint the citizens of Redlands with the existence of the Redlands Muncipal Airport.

Resolution No. 4748

Traffic

Acting Police Chief Ben Meeker presented Resolution No. 4748, a resolution of the City Council of the City of Redlands establishing speed zones for San Bernardino Avenue pursuant to Title 10 of the Redlands Municipal Code, which was unanimously approved by the City Council.

Resolution No. 4750 Traffic

Acting Police Chief Ben Meeker presented Resolution No. 4750, a resolution of the City Council of the City of Redlands establishing no parking on the east side of North Grove Street between Lugonia Avenue and Cornell Avenue pursuant to Title 10 of the Redlands Municipal Code. Following discussion, Resolution No. 4750 was unanimously adopted by the City Council.

Acting Community Development and Planning Director Michael Granado reviewed the Planning Commission actions from their meeting of March 26, 1991, and recommended this report be continued to the next meeting when the report would be published. This recommendation was unanimously approved by Council.

Acting Fire Chief John Budd presented information regarding the household hazardous waste program. Council commended the members of the Fire Department for their efforts in this field.

Agreement

Acting Deputy Public Works Director (Streets) Don Stephens recommended that the City Council authorize award of a contract and authorize an agreement between the City of Redlands and Cutler and Associates, Inc. to furnish consulting services to acquire the property rights necessary to widen both sides of Judson Street between Pioneer and Lugonia Avenues in the amount of \$29,100.00. Acting City Treasurer Sarah Glass responded to Council's questions and presented an update of revenue projections for 1990-91. Following discussion, this recommendation was unanimously approved by the City Council.

Acting Director of Public Works Nagan Ha Ngo presented the monthly contract monitoring reports for projects currently being administered by the Public Works Department and responded to questions from the Councilmembers.

Grant Deed

Acting Deputy Public Works Director (Streets) Don Stephens recommended Council approve and authorize execution of a grant deed to Andly Development Company for property located north of the Rees Well site on Pennsylvania Avenue. This recommendation was unanimously approved by the City Council.

Resolution No. 4752 Grant Funds

Acting Community Services Director Jennifer Cowen recommended the City Council adopt Resolution No. 4752, a resolution of the City Council of the City of Redlands approving the application for Land and Water Conservation Funds for the Sylvan Park Picnic and Trail Improvements Project, and explained

the improvements to be done. Resolution No. 4752 was unanimously adopted by the City Council.

Acting Recreation Superintendent Carlos B. Acuna reported about the Clement Junior High School field lighting project.

Agreement

Acting Deputy Public Works Director (Utilities) Matt Kamper recommended the City Council approval an agreement for engineering consulting services to construct the California Street Landfill monitoring well with Lee & Ro Consulting Engineers as required by State legislaation. This recommendation was unanimously approved by the City Council.

Funds Building Improvements

Acting Finance Director Chris Urbancik recommended the City Council approve an appropriation of \$10,000.00 within the Public Works Department. Following discussion, this recommendation was unanimously approved by the City Council.

Acting Cemetery Supervisor Rick Evans responded to Council that the cemetery grounds benefited greatly from the recent rains.
