The purpose of this meeting was to provide an orientation and briefing for members of the Utility Users' Tax Advisory Committee. A chronology of significant events relating to the Utility User's Tax was presented by City Manager Luebbers. Finance Director Chapman presented information showing the amounts of "take-away" of City of Redlands' revenue by the State of California since fiscal year 1990-91; specified functional expenditures of the proposed two percent Utility Users' Tax; a summary of revenue and expenditures of the current Utility Users' Tax as of September 30, 1996; and a five year budget summary (1995-1996 through 1999-2000) for the General Fund. Department heads explained how the receipts have been expended since the inception of the current Utility Users' Tax.
