This special meeting of the City Council was called for the purpose of considering Employee-Employer Relations and was called to order at 4:30 P.M. and immediately adjourned to a closed session to discuss the tentative agreement with the Redlands Police Officers Association.

The public meeting was reconvened at 4:35 P.M. Councilman Roth stated he had read the Memorandum of Understanding between the City and the Redlands Police Officers Association, Inc. and found it satisfactory to his desires and moved for adoption, effective September 28, 1981. Councilman Riordan seconded the motion.

The Memorandum of Understanding, which commences on September 28, 1981 and continues through and including June 30, 1982, contains a salary adjustment increase of 7.5 percent for each affected employee and overtime compensation subject to terms and conditions listed in the Memorandum of Understanding, as well as maintenance of existing benefits.

For the record, Councilman Martinez verified that the Police Association and City Council, as well as the Administration had agreed to the Memorandum of Understanding. Sgt. Barry Bruins, president of RPOA, confirmed the association had.

Councilman Roth made a statement for Councilman Gorman, who was unable to attend this special meeting. The statement being that if he were present, Mr. Gorman would have opposed this action on the grounds it is excessive and will cause significant hardships.

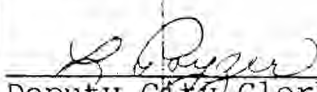
AYES: Councilmembers Martinez, Riordan, Roth

ABSENT: Councilmember Gorman

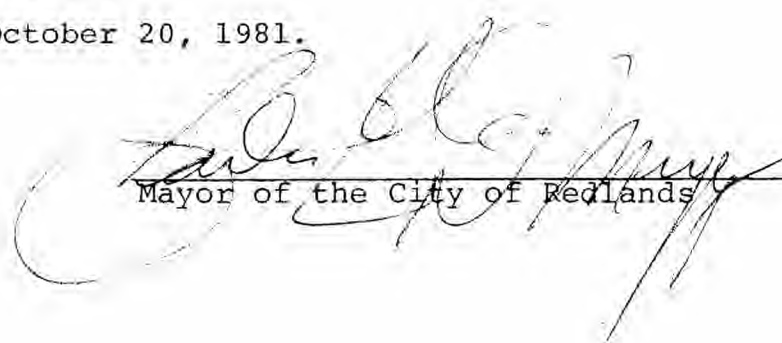
