

ORDINANCE NO. 251...

An ordinance amending section I of ordinance No. 161 as amended by ordinance No 226, and also amending section 2 of said Ordinance No 161 in relation to the numbering of buildings; also adding a new section to Ordinance No 159, to be known as section I 1/2, relating to the changing of the names of certain Streets and Avenues.

The Board of Trustees of the City of Redlands, do ordain as follows;

Section I ; Section I of ordinance No. 161 passed on the 16th day of August A.D. 1893, entitled "An Ordinance requiring the numbering of buildings in a portion of the City of Redlands, and establishing certain regulations therefor" as amended by ordinance No. 226 passed on the 8th. day of September A.D. 1897, is hereby amended, so that said section shall read as follows;

Section I ; Within that portion of the City of Redlands, bounded as follows to wit; Beginning at a point on the East side of Orange Street, 50 feet north of its intersection with Brockton Avenue; thence east to a point 50 feet ^{east} of its intersection with the east line of Tribune Street; thence south to a point 50 feet north of Colton Avenue; thence east to a point 50 feet east of the intersection of east line of East Street with Colton Avenue; thence south to a point 50 feet north of north line of Sylvan Boulevard ; thence along a line 50 feet north of the northerly line of Sylvan Boulevard to a point 50 feet east of the East line of Judson Street; thence south to Citrus Avenue; Thence south-easterly along a line 50 feet east of east line of Redlands Street to a point 50 feet south of intersection of Redlands street with south line of Highland Avenue; thence south westerly along Highland Avenue to a point 50 feet east of intersection of Highland Avenue and Redervoir street; thence

with Crescent Avenue; thence southeasterly along a line 50 feet east of east line of Elm Street, to a point 50 feet north of intersection of north line of Summit Avenue with east line of Elm street; thence along a line 50 feet easterly of the north-east side of Summit Avenue to a point 50 feet south of the southerly line of Oak street; thence southwesterly to a point 50 feet easterly of, intersection of south line of Oak street with east line of Franklin Avenue; thence southeasterly along a line 50 feet easterly of Franklin Avenue to a point 50 feet north of north line of Hilton Avenue; thence east to east end of Hilton Avenue; thence south to a point 50 feet south of south line of Hilton Avenue; thence west to a point 50 feet east of the intersection of east line of Garden street with south line of Hilton Avenue; thence south-east along a line 50 feet east of east line of Garden street to Elizabeth street; thence west along the north line of Elizabeth street to Fountain Avenue; thence north-easterly along east line of Fountain Ave. to its intersection with the south line of California street; thence west along the south line of California street to a point 50 feet south of its intersection with south line of, Crescent Avenue; thence west along a line 50 feet south of south line of Crescent Avenue, to a point 50 feet west of its intersection with west line of Crown street; thence north to a point 50 feet north of ^{its} intersection with north line of Highland Avenue; thence easterly along a line 50 feet northerly of north line of Highland Avenue to a point 50 feet west of west line of San Mateo street; thence north-west along a line 50 feet westerly of west line of San Mateo street to a point 50 feet southerly of south line of Clifton Avenue; thence southwesterly along a line 50 feet southerly of south line of Clifton Avenue to a point 50 feet west of the west line of Sunnyside Avenue; thence

of north line of Cypress Avenue, to a point 50 feet west of westerly line of San Mateo street; thence northwest to a point 50 feet north of intersection of west line of San Mateo street with north line of Brookside Avenue; thence northeasterly to a point 50 feet westerly of the intersection of west line of Center st. with the north line of Brookside Avenue; thence north to and along a line 50 feet west of the west line of Texas street to a point 50 feet north of its intersection with the north line of Brookton Avenue; thence east to beginning. All buildings having a frontage on any street or Avenue shall be numbered by the owner, Agent or occupant thereof as hereinafter provided, and in conformity with the regulations in this Ordinance prescribed.

SECTION II: section II of said ordinance No. 161 is hereby amended so as to read as follows;

SECTION II; Brookside Avenue together with east and west Citrus Avenue shall form the base line for numbering all north and south streets and avenues, excepting Church street, Sixth street and Orange street, which shall be numbered from the southern terminus^{thereof} towards the north.

Orange street to its intersection with Cajon street, and Cajon street to its intersection with South Avenue, and South Avenue from its intersection with Garden street to and along Live Oak Canyon Road to the intersection thereof with the east line of the City, shall be the base line for numbering all east and west streets and avenues north and south of and including East and West Citrus Avenues. Brookside Avenue shall be numbered from its intersection with West Citrus Avenue towards the south-west. For the purpose of numbering on a street or avenue blocks shall be counted from the point of commencement of numbering, and the first number allotted in the first block shall be ^{numbered} "1", and the first number in the second block shall be numbered "101" and the number in each block shall commence with a new hundred.

Odd numbers shall be assigned to the left hand side of the street or avenue, and even numbers to the right hand side, and the num-

1000 feet in length ,60 feet frontage shall be allowed to a number. Provided ,that whenever in the space allowed as aforesaid to a number there shall be a hallway leading up stairs to tenements fronting on the street or Avenue, such hallway or tenements shall be given an additional half number

Section III; A new section to be known as section I I/2 is hereby added to said Ordinance No. 159, which section shall read as follows;

Section I I/2; So much of Vine street, Olive Avenue, Fern Avenue, Home Place street, Cypress Avenue, Palm Avenue, Highland Avenue, Crescent Avenue, and South Avenue, as are easterly of Cajon street, shall have the word "East" prefixed to the names of each of said streets and Avenues respectively.

And so much of said streets and avenues as are westerly of Cajon Street shall have the word "West" prefixed to each of said streets, and avenues respectively.

Section IV; All Ordinances or parts of Ordinances in conflict with this Ordinance are hereby repealed.

Section V; This Ordinance shall take effect from and after the date of its passage. *and publication*
