

ORDINANCE NO. 1058

AN ORDINANCE OF THE CITY OF
REDLANDS AMENDING CHAPTER
63 OF THE REDLANDS ORDINANCE
CODE ENTITLED "BICYCLES."

Be it ordained by the City Council of the City of Redlands that the following sections of Chapter 63 of the Redlands Ordinance Code enacted on the 7th day of June, 1955, be and the same is hereby amended to read as follows:

SECTION 6312. ISSUANCE OF LICENSES. The Police Department of the City of Redlands is hereby authorized and directed to issue, bicycle licenses which shall be effective upon the 1st day of January 1958, to and including December 31, 1960 and thereafter issue license plates every third year. License plates shall be issued between January 1st and February 4th succeeding said expiration date.

Section 6315. LICENSE PLATES; REGISTRATION CARDS. The City of Redlands shall provide for a fee each three years metallic or self-sticking license plates together with registration cards, said license plates and registration cards having numbers stamped thereon in numerical order beginning with number one and the letters "RBL" or Redlands stamped thereon.

Section 6316. ATTACHMENT OF PLATES. ISSUANCE OF CARDS. Such license plates shall be suitable for attachment upon the frames of bicycles and it shall be the duty of the Police Department to attach one such license plate to the frame of each bicycle and to issue a corresponding registration card to the licensee fee herein provided for.

Section 6317. REMOVAL OF PLATES. Such license plate shall remain attached during the period the license is valid.

Section 6319.1. ISSUANCE OF DUPLICATES. The Police Department may thereupon issue duplicates thereof at a cost of fifty cents (50c).

Section 6321. INITIAL, RENEWAL FEE. The initial license fee and renewal fee to be paid for each bicycle shall be One Dollar and Fifty Cents (\$1.50). A bicycle purchased after license deadline may be licensed for 50c for each year remaining in the three year period or portion of remaining year upon proof of sale.

Section 6321.1. PENALTY. A penalty of \$1.00 shall be added upon any application for annual renewal of registration made on or after February 4th except as provided in Section 6321 of this ordinance.

Section 6322. PAYMENT OF FEES. All licenses shall be payable in advance to the Chief of Police or his

representative, who is hereby designated as the License Collector for all fees due under this Chapter.

Section 6324. TRANSFER FEE. Pursuant to Article 634, a bicycle license may be transferred when the ownership of said bicycle is transferred; and a fee of fifty cents (50c) shall be paid for the registration of such transfer. (Fee for Duplicate License; See Section 6319.1 above.)

SECTION 6332. DEALER'S REPORT OF SALES. All persons engaged in the business of selling new or second hand bicycles are hereby required to make a weekly report to the Police Department giving a list of all sales made by such dealers, which list shall include the name and address of each person to whom sold, the kind of bicycle sold, together with a description and frame number thereof, and the number of the metallic or self-sticking license plate attached thereto, if any.

Section 6333. RENTAL BICYCLES; REGISTRATION; PLATES. All persons engaged in the business of renting bicycles are hereby required to register the number of bicycles to be rented, and to secure license plates for the said number of bicycles and a registration card for each license period.

Section 6352. IMPOUNDING OF BICYCLE. The Police Department of the City of Redlands, or any of the members thereof, may impound and retain possession of any bicycle operated in violation of any of the provisions of this ordinance, and retain possession of the same until the license provided for herein is obtained by the owner of said bicycle.

EFFECTIVE DATE. This ordinance shall take effect in 30 days and prior to 15 days from the passage hereof shall be published once in the Redlands Daily Facts, a newspaper of general circulation, printed and published in the City of Redlands, California.
