

An Ordinance providing for
the cleansing of cess-pools and
privies, and prescribing certain
sanitary regulations, and repealing
Ordinance 72

The Board of Trustees of
the City of Oakland do ordain
as follows:

Section 1. Every person owning or
corporation owning or occupying
any premises, or any part thereof,
within the City of Oakland do-
ing thereon or appurtenant
thereby, a cess-pool or a privy,
shall, ^{up} promptly said cess-pool,
or privy, or cause the same to
be, thoroughly cleaned whenever in the
judgment of the Health Officer, or
of said City or the Secretary of
the Board of Health of said
City, such cess-pool or privy is
offensive, or a menace to health
or likely to become so after
within ~~four~~ forty-eight hours after
such ~~cleaning~~ ^{cleaning} shall be
privies, or occupiers, ~~as~~ so noti-
fied by said Health Officer.
I. Do not

or otherwise removing the contents
thereof into a water-tight covered
wagon box or tank, ~~a~~ such con-
tents shall immediately be carried
away in said box or tank, secured
by band tightly closed, and con-
vayed to a distance of at least
~~half a mile~~ ^{from any dwelling}
or travelled ~~highway~~ ^{thoroughfare},
or avenue, and ~~the~~ ^{these} buried, or
otherwise so disposed of, as not
to be ^{to} cause a nuisance, or, when
given to the owner, immediately
after such care-punt or firing shall
have been so cleared. The cause
shall be, by the owner, owner,
occupier or occupiers of said
premises, thoroughly disinfect-
ed ~~with~~ ^{such} disinfectant or
oil in ^{the} tanks as shall be
prescribed by ~~the~~ ^{the} health
officer or said local authority, and
the said wagon box or tank need
for no repainting said contents
shall immediately there after
be thoroughly disinfected by
the owner thereof and person or
person making the same, and
with the like disinfectant
or disinfectants as aforesaid,

be cleaned as aforesaid except
in the night-time between the
hours of 11 o'clock P.m. and
5 o'clock A.m. And no wagon
or tank with which the contents
of any cess-pool or pissing are
being so carted away as afore-
said shall be permitted by
the person or persons in charge
of the same to stand any-
where in said city, other than at
the place of public deposit of
such contents ^{three} for a longer
time than ¹¹ minutes.

Section ⁶ ~~3~~ Whenever the Health Officer
or the secretary of the Board
of Health of the city shall
be informed that any prem-
ises in said city are, either
from ~~insufficiency~~ ^{inadequacy} or
~~cleaning~~ the presence of un-
wholesome accumulations, mat-
ter or deposits, or a lack of
disinfection, in such a condi-
tion as to be a menace ~~to~~
the health ^{Health} the next mor-
row, said Officer or said Sec-
retary shall hang the power and

shall therefrom nothing the owner,
anyone, occupier or occupiers of
said premises to either, as the
case may require, ~~for the~~
~~purpose of~~ ~~the~~ ~~re-~~
move such accumulations or
deposits, or to ~~make~~ ~~such~~ dis-
fect said premises with such
disinfectants as shall be di-
rected by the Secretary prescrib-
ed; and the responsibility of such
notice shall be complied with
by such owner, any occupier or
occupiers within ^{four} twenty days
after the ~~the~~ same shall be
given;

Actin and shall be and is
hereby declared to be a mi-
nemeanor, and shall be pun-
ishable by a fine of not less
than twenty dollars nor more
than one hundred dollars,
or by imprisonment in the City
Prison for not less than ~~three~~
days nor more than ten days
