ORDINANCE No. 1001

AN ORDINANCE RELATING TO THE MEMBERS OF THE PLANNING COMMISSION OF THE CITY OF REDLANDS, AND AMENDING CHAPTER 91, ARTICLE 911, SECTIONS 9111. to 9113.1 INCLUSIVE OF THE ORDINANCE CODE OF THE CITY OF REDLANDS.

The City Council of the City of Redlands does ordain as follows:

SECTION ONE: That Chapter 91, Article 911, Sections 9111. to 9113.1, adopted by the Ordinance Code of the City of Redlands, on June 7th, 1955, by Ordinance No. 991, be and the same is hereby amended to read as follows:

Article 911

Members

SECTION 9111. NUMBER OF MEMBERS: The Planning Commission shall consist of Ten (10) members as follows:

SECTION 9112. VOTING MEMBERS: NUMBER: DESIGNATION: Seven Members of the Commission shall be voting members who shall be designated respectively Nos. 1, 2, 3, 4, 5, 6 and 7.

SECTION 9112.1 APPOINTMENT OF 7 COMMISSIONERS, QUALIFICATIONS: Voting Commissioners Nos. 1 to 7 inclusive shall be appointed as hereinafter designated by the Mayor with the approval of the Council, from the citizens at large of this City who are not officials of this City.

SECTION 9112.2 CITY PLANNING DIRECTOR AS SECRETARY: The City Planning Director shall serve as Secretary of the Commission.

SECTION 9113. NON-VOTING MEMBERS: The City Attorney shall be Commissioner No. 8, and Commissioner No. 9 shall be a member of the City Council to be selected by the Council, and Commissioner No. 10 shall be the City Manager.

SECTION 9113.1 ADVISORY COMMISSIONERS: Commissioners No. 8, 9 and 10 shall be advisory only, and shall not have the power to make, second or vote upon any motion, resolution or matter under consideration by the Commission.

SECTION TWO: Effective date, this Ordinance shall be in force and take effect as provided by law.

SECTION THREE: The City Clerk shall certify to the adoption of this ordinance and cause it to be published once in the Redlands Daily Facts, a newspaper of general circulation printed and published in this City.
