ORDINANCE NO. 2359

AN ORDINANCE OF THE CITY OF REDLANDS AMENDING CHAPTER 10.40 OF THE REDLANDS MUNICIPAL CODE RELATING TO THE PARKING OF COMMERCIAL VEHICLES

THE CITY COUNCIL OF THE CITY OF REDLANDS DOES ORDAIN AS FOLLOWS:

Section 1. Section 10.40.150 of the Redlands Municipal Code relating to parking of commercial vehicles is hereby deleted in its entirety and rewritten to read as follows:

"10.40.150 Parking of commercial vehicles in residential district prohibited.

- A. No person shall park or stand any commercial vehicle, truck tractor, semitrailer or trailer having a manufacturer's gross vehicle weight rating of ten thousand pounds or more, on any street, alley or parkway in any residential district of the City.
- B. No person shall stop, stand or park any commercial vehicle, truck tractor, semitrailer or trailer having a maximum gross weight exceeding ten thousand pounds for a continuous period of time in excess of two hours in any non-residential district of the City. Each consecutive two hour period shall be considered a separate violation for the purpose of this subsection.
- C. The provisions of this Section shall not apply to:
 - Any vehicle making pickups or deliveries of goods, wares or merchandise
 from or to any building or structure located on the restricted streets and
 highways, or for the purpose of delivering materials to be used in the actual
 and bona fide repair, alteration, remodeling or construction of any building
 or structure upon the restricted streets or highways for which a building
 permit has previously been obtained.
 - 2. Any vehicle parked in connection with and in the aid of the performance of a service to or on a property in the block in which said vehicle is parked.
 - 3. Any passenger bus under the jurisdiction of the Public Utilities Commission.
 - 4. Any vehicle owned by a public utility or licensed contractor if necessary for use in connection with the installation or repair of any public utility.

- 5. Any vehicle owned by the City, County, State or licensed contractor engaged in the installation, maintenance or repair of any public property, utility or highway.
- Any authorized emergency vehicle as defined by the California Vehicle Code.
- D. For the purpose of this Section, the term "residential district" shall mean any single family or multiple family zoning districts in the City.
- E. Any commercial vehicle, truck tractor, semitrailer or trailer having a maximum gross weight exceeding ten thousand pounds left parked or standing on any street, alley or parkway in excess of 24 hours may be towed away pursuant to California Vehicle Code Section of 22651(n).
- F. Any person who violates any of the provisions of this Section shall be guilty of an infraction."
- Section 2. With the exception of alleys, this ordinance shall not apply to any street in a non-residential district until signs or markings giving adequate notice of the provisions of this ordinance have been placed.

Section 3. The Mayor shall sign this ordinance and the City Clerk shall certify to the adoption of this ordinance and shall cause it, or a summary of it, to be published once in the Redlands Daily Facts, a newspaper of general circulation within the City, and thereafter, this ordinance shall take effect in accordance with law.
