

An ordinance granting to
the Bear Valley Irrigation Com-
pany the right to lay open-
ate and maintain Steel
Pipe Lines in and through
Lugonia Avenue.

The Board of Trustees of
the City of Oakland do ord-
ain as follows:-

Section 1. ~~There~~ There is hereby granted
to the Bear Valley Irrigation
Company, a corporation, the right
to lay, construct, operate and
maintain one or more Steel
Pipe Lines of about twenty
four inches in diameter in
and along Lugonia Avenue
in said City from the east
boundary line of said City to
its west boundary line, and
also the right to make with
such Pipe Line or Lines such
connections as may hereafter
be required; provided, that such
Pipe Line or Lines shall be
so laid that the top thereof
shall be at least two feet
beneath the ~~level~~ surface of the
said Avenue, and that the same
