ordinance no. 419

An ordinance of the City of Redlands perviding for the issuance of building permits, and fixing fees therefor.

The Board of Trustees of the City of Redlands do ordain as follows:

permit or allow or to commence or proceed with the erection, construction, alteration, repair moving endemolitien exceeding for the cost, (restoration of plastering or painting excepted) of any buildingor other structure in the City of Reslands, unless the permit to do such work has been first obtained as hereinafter provided.

with the Building Inspector of said city the application therefor, which application shall set forth the description of the land upon which the proposed work is to be done, the general dimentions of the building to be constructed, altered, repaired, moved or demplished, and the number and height of stories thereof, the names of the owner, the architect, and the contractor, an estimate of the cost of the proposed work, the surpose for which such building, alterations or repair is desired, and such other matter as the Board of Trustees may hereafter require. Thereupon the said Building Inspector shall issue to such applicant the permit for the proposed work upon payment to him of the fee for such permit herein provided as follows to-wit:

Where the cost of the proposed work does not exceed Five Hundred Dollard (\$500.00), One Dollar (\$1.00); where the cost of the porposed work exceeds Five Hundred Dollars (\$500.00), One Dollad and Fifty Cents (\$1.50). for the first

(\$1000.00) but not exceeding & Ten Thousand Dollars (\$10,000), One Dollar (\$1.00); and for each additional One Thousand Dollars tix (\$1,000.00) or fraction thereof of the cost of such work above Ten Thousand Bollars (\$10,000.00) and not exceeding Thirty Thousand Dollars (\$30,000.00), Fifty Cents. (\$.50); and for each additional One Thousand Dollars (\$1000.00) or fraction thereof of the cost of such work avove Thirty Thousand Dollars (\$30,000.00) and not exceeding Fifty Thousand Dollars (\$50,000.00), Forty Cents (\$.40.); and for each additional One Thousand Bollars (\$1000.00) or fraction thereof of the cost of such work axx above Fifty Thousand Dollars (\$50,000.00) and not exceeding One Hundred Thousand Dollars (\$100,000.00), Twenty-five Cents (\$.25); and for each additional One Thousand Bollars (\$1900.00) or fraction thereof of the cost of such work above One Hundred Thousand Dollars (\$100,000.00), Twenty Sents (\$.20).

In case of moving of any building without entering thon any public street, alley or place in so doing, the cost of moving added to the cost of any repairs, additions of alterations to be made to such building after the moving thereof, shall constitute the total cost for the purpose of determining the fee to be paid for the permit according to the above schedule.

SECTION #. Any person violating any of the provisions of this ordinance shall be guilty of a misdemeanor and upon conviction, shall be punishable by a fine not exceeding more than Dollars. (\$50.00).

SECTION 4. This ordinance shall take affect and be in force from and after its passage.
