ORDINANCE NO. 1197

AN ORDINANCE AMENDING ORDINANCE NO. 1067, OF THE CITY OF REDLANDS CONCERNING THE ERECTION, CONSTRUCTION, ENLARGEMENT, ALTERATION, REPAIR, MOVING, REMOVAL, CON-VERSION, DEMOLITION, OCCUPANCY, EQUIPMENT, USE, HEIGHT, AREA AND MAINTENANCE OF BUILDINGS OR STRUCTURES IN THE CITY OF REDLANDS, PROVIDING FOR THE ISSUANCE OF PERMITS AND COLLECTION OF FEES THEREFOR; DECLARING AND ESTABLISHING FIRE DISTRICTS; PROVIDING PENALTIES FOR THE VIOLATION THEREOF, AND AMENDING UNIFORM BUILDING CODE HEREIN ADOPTED BY ADDING NEW SECTIONS THERETO, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT THEREWITH.

The City Council of the City of Redlands does ordain as follows:

SECTION ONE: That the Uniform Building Code, 1955 Edition, with Appendix, as adopted in Ordinance No. 1067, is hereby amended by deleting Table No. 3-A, "Building Permit Fees," and adding thereto Table No. 3-A, "Building Permit Fees", from the Uniform Building Code with Appendix, 1961 Edition, to read as follows:

More than \$100.00, to and including \$400.00	3.00

Each additional \$1,000.00 or fraction, to and	
including \$25,000.00	3.00
Each additional \$1,000.00 or fraction, to and	
including \$50,000.00	2.50
Each additional \$1,000.00 or fraction, to and	
including \$100,000.00	1.50
Each additional \$1000.00 or fraction,	
more than \$100,000.00	1.00

SECTION TWO: Each provision of this ordinance shall be separate and severable and in the event any specific provision is declared void or invalid no other section, otherwise legal and valid, shall be affected thereby.

SECTION THREE: All other ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION FOUR: This Ordinance shall be in force and effect as provided by law.

SECTION FIVE: The City Clerk shall certify to the passage of this Ordinance and shall cause the same to be published once in the Redlands Daily Facts, a daily newspaper designated for that purpose.
