ORDINANCE NO. 2275

AN ORDINANCE OF THE CITY OF REDLANDS AMENDING CHAPTER 3.52 OF THE REDLANDS MUNICIPAL CODE RELATING TO WATER RATES

WHEREAS, based upon review of the fiscal projections for the Water Fund Group and testimony presented to the City Council of the City of Redlands by City staff, this City Council has determined that it is desirable to reduce the City's rates for water usage, and at the same time cover the reasonable costs incurred by the City for providing such service; and

WHEREAS, the California Health and Safety Code Section 5471 requires that any change in water rates be made by ordinance adopted by a two-thirds vote of the City Council;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF REDLANDS AS FOLLOWS:

<u>SECTION ONE</u>: Section 3.52.040, the Water Service Rate Schedule, Item A., of the Redlands Municipal Code is hereby amended to read as follows:
