

ORDINANCE No. 365

AN ORDINANCE OF THE CITY OF REDLANDS fixing the water rates for the City of Redlands for the year commencing

July 1st, 1905 and ending June 30th, 1906.

The Board of Trustees of the City of Redlands do ordain as follows:

Section 1. That for the year commencing on the first of July 1905 and ending on the 30th day of June 1906, the monthly rates (unless otherwise fixed) of compensation for which any person, company, or corporation, engaged in the business of supplying water to the inhabitants of the City of Redlands, for family uses, for private purposes, for municipal uses, for irrigation and for all public purposes of said city, are hereby fixed and established as follows, to wit:

1. For each private residence occupied by not more than five persons, \$1.00; for each additional person above five persons, 10¢.
2. Bath tubs in a private house, 25¢.
3. Water closets in private house, 25¢.
4. For irrigation of lots not exceeding 1/4 acre including the irrigation of ornamental plants, trees, and shrubbery, \$1.00
5. For watering carts for street sprinkling, each cart per day, payable weekly, \$1.00
6. For each head of stock kept by private family not over two, 25¢; for each head of stock over two, 10¢.
7. Small stores and business offices, \$1.50
8. Large stores and business offices employing more than four persons, \$2.00
9. Offices in second and third stories, 50¢.
10. Stores using soda water fountains in addition to any other, each 50¢.
11. Bakeries, \$2.00
12. Laundries, \$5.00
13. Dentist's offices, \$1.00
14. Public horse watering trough, 50¢.
15. Barber shops, per chair, 50¢
16. Public bath tubs, each \$1.00
17. Public water closets with urinals, \$1.00
18. Wagon and Blacksmith Shop, not exceeding two forges, \$2.00; for each additional forge, 25¢.
19. Livery, Feed, and Sale Stable, for each horse kept, 50¢.
20. Lodge or meeting room, \$1.50
21. Photograph Studio, \$2.00
22. Restaurant, \$2.00
23. Packing Houses employing not more than ten persons, \$2.50; for each additional person, 5¢.
24. Hotels, lodging or boarding houses, containing not over five rooms, \$2.50
25. Hotels, lodging or boarding houses, containing from five to ten rooms, \$3.00

26. Hotels, lodging or boarding houses, containing over ten rooms, for each additional room, 10¢.
27. Fountains, not to be used over twelve hours per day, 1/16 jet, \$2.00
28. Fountains, not to be used over twelve hours per day, 1/8 jet, \$6.00
29. Flushing sewer tanks, not more than three times in twenty-four hours, \$2.00
30. Building purposes, each 1000 brick wet and laid, 15¢.
31. Building purposes, each barrel of lime or cement slacked, 15¢.
32. Steam engines, under five horse power, \$2.00
33. Steam engines, over five horse power, \$3.00
34. Gasoline engines, for water used in running the machinery thereof, \$2.00
35. Motors for running coffee mills, \$2.00
36. Lawns, for each square yard over one hundred square yards, 1/2¢.
37. Schools, twenty-five scholars or less, \$2.00
38. Schools, more than twenty-five scholars, for each additional fifty, or part thereof, 25¢.
39. Brickyard, meter rate.
40. Where water is furnished by meter, the rate shall not exceed ten cents for each 1000 gallons.
41. For all fire hydrants in use by the city, provided that there shall be maintained a pressure of not less than 60 pounds per square inch, including the flushing of the paved streets therein not exceeding once each week, \$70.00 per month.
42. City jail, \$1.00

Section 2. The bills for water to be furnished for any purpose (except to the City of Redlands) at fixed monthly charges as above provided for, shall be due and payable on the first day of each month in advance. Whenever for any reason the water so paid for in advance shall not have been actually furnished during the hours from five o'clock A. M. until nine o'clock P. M., the charge for the following month shall be proportionately reduced for the time, within said hours, during which the customer is not supplied.

Section 3. This ordinance shall take effect and be in force from and after July 1st, 1905.
