RESOLUTION NO. 4888

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDLANDS RELATING TO REMOVAL OF LANDS FROM AGRICULTURAL PRESERVES

WHEREAS, on February 19, 1980, the City Council of the City of Redlands adopted Resolution No. 3649 establishing policy criteria for the removal of lands from agricultural preserves; and

WHEREAS, in May 1990, in connection with the City's annexation of certain lands located in the San Timoteo Canyon area, the City Council entered into agreements with several property owners in the annexation area whereby the City agreed to commence proceedings for the removal of certain properties from agricultural preserve status in exchange for such property owners' support of the City's annexation; and

WHEREAS, those property owners have now requested the City comply with the terms of the agreements and commence proceedings for the removal of their properties from agricultural preserve status;

NOW, THEREFORE, be it resolved by the City Council of the City of Redlands as follows:

Section 1. Pursuant to the requirements of Government Code Section 51220 et seq., this City Council hereby directs the City's planning department to commence proceedings for the removal of the properties described in Exhibit "A," attached hereto, from agricultural preserve status.

Section 2. Although the properties seeking removal from agricultural preserve status do not satisfy the City's criteria for removal contained in Resolution No. 3649, this City Council hereby determines that the properties described in Exhibit "A" may be removed from agricultural preserve status if the City finds that its goals of (1) discouraging premature and unnecessary conversion of agricultural land to urban uses, and (2) discouraging discontinuous urban development patterns which unnecessarily increase the costs of community services to Redlands' citizens, will not be frustrated or adversely affected.



MEMORANDUM

TO: MAYOR, CITY COUNCIL AND CITY MANAGER

FROM: CITY ATTORNEY

RE: REMOVAL OF LANDS FROM AGRICULTURAL PRESERVE STATUS

Pursuant to your direction at your last Council meeting, we have prepared the attached resolution which would direct the City's planning staff to commence proceedings for the removal of certain properties located in the San Timoteo Canyon area from agricultural preserve status. The adoption of this resolution does not affect the City's existing criteria for removing lands from agricultural preserves. Rather, it acknowledges commitments made by the City Council during the City's Annexation No. 72 proceedings and provides that lands subject to certain "preannexation agreements" may be removed from agricultural preserve status if two findings are made, despite the lands' noncompliance with the City's policy criteria for removal from agricultural preserves.
