WHEREAS, the City Council of the City of Redlands desires to initiate proceedings pursuant to the Cortese-Knox Local Government Reorganization Act of 1985, Division 3, commencing with Section 56000 of the California Government Code, for the annexation of territory hereinafter described; and

WHEREAS, the territory proposed to be annexed is inhabited, and a description of the boundaries of the territory is set forth in Exhibit A attached hereto and by this reference incorporated herein; and

WHEREAS, this proposal is consistent with the sphere of influence of the affected city; and

WHEREAS, the reasons for this proposed annexation are as follows: The annexation of the hereinbefore described territory will contribute to the orderly growth of the City, provide the proper control of street layout, drainage, sanitary sewer design, and insure the proper use of land in conformity with the overall plan of the City;

NOW, THEREFORE, this Resolution of Application is hereby adopted and approved by the City Council of the City of Redlands, and the Local Agency Formation Comission of San Bernardino County is hereby requested to take proceedings for the annexation of territory as described in Exhibit A, according to the terms and conditions stated above and in the manner provided by the Cortese-Knox Local Government Reorganization Act of 1985.
