

RESOLUTION NO. 2201

RESOLUTION DECLARING THE INTENTION OF THE COUNCIL OF THE CITY OF REDLANDS TO INITIATE ON ITS OWN MOTION PROCEEDINGS TO ANNEX CERTAIN UNINHABITED TERRITORY, HEREINAFTER DESCRIBED AND DESIGNATED AS "ANNEXATION NO. 12" TO THE CITY OF REDLANDS AND AUTHORIZING AND DIRECTING THE CITY MANAGER TO FILE SUCH PROPOSAL WITH, AND SUBMIT SUCH PROPOSAL TO THE BOUNDARY COMMISSION OF THE COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA, FOR A REPORT THEREON AS REQUIRED BY LAW.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF REDLANDS:

SECTION ONE: That the Council of the City of Redlands, for the reasons hereinafter mentioned, desires, intends and proposes to initiate on its own motion, as soon as it can legally do so, proceedings to annex to the City of Redlands all of the territory hereinafter described, as uninhabited territory, by virtue and in accordance and in compliance with the provisions of the Annexation of Uninhabited Territory Act of 1939.

SECTION TWO: That the said Council's reasons for proposing to initiate said annexation proceedings as aforesaid are as follows: That the annexation of the hereinafter described territory will contribute to the orderly growth of the city.

SECTION THREE: That said territory, which said Council proposes to annex as aforesaid, is hereby described and identified as "Annexation No. 12," and said territory includes, consists of and is further described as all that real property situated in the County of San Bernardino, State of California, described as follows:

All that portion of Lots 5, 6, 7 and 8, Block 71, Rancho San Bernardino in the County of San Bernardino, State of California as shown on Record of Survey recorded in Book 17 of Maps, Page 41 thereof, Records of said County and described as follows:

Commencing at the northeast corner of Block 71, Rancho San Bernardino; thence north $89^{\circ} 25' 19''$ west 51.00 feet to the True Point of Beginning; thence north $89^{\circ} 25' 19''$ west 2593.29 feet; thence south $0^{\circ} 35' 11''$ west 41.25 feet; thence north $89^{\circ} 25' 19''$ west 2603.06 feet; thence south $0^{\circ} 36' 11''$ west 1159.61 feet; thence north $62^{\circ} 58' 16''$ east 331.44 feet; thence south $87^{\circ} 31' 44''$ east 250.00 feet; thence north $80^{\circ} 58' 16''$ east 300.00 feet; thence south $82^{\circ} 01' 44''$ east 140.00 feet; thence north $89^{\circ} 58' 16''$ east 240.00 feet; thence north $66^{\circ} 58' 16''$ east 300.00 feet;

thence south 75° 31' 44" east 200.00 feet; thence south 87° 21' 44" east 100.00 feet; thence north 79° 28' 16" east 460.00 feet; thence north 82° 58' 16" east 368.17 feet; thence north 82° 50' 00" east 439.40 feet; thence north 71° 20' 00" east 500.00 feet; thence south 79° 40' 00" east 870.00 feet; thence south 56° 40' 00" east 640.00 feet; thence south 89° 10' 00" east 269.69 feet; thence north 0° 36' 41" east 364.80 feet; thence south 89° 23' 19" east 20.00 feet; thence north 0° 36' 41" east 721.14 feet to the True Point of Beginning. Approximately 95 acres.

SECTION FOUR: That the City Manager of the City of Redlands is hereby authorized and directed to apply to the Boundary Commission of the County of San Bernardino, State of California, for a boundary report on proposed Annexation No. 12 by said Commission in accordance with the Government Code of said State.
