RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDLANDS, CALIFORNIA, DIRECTING THE CITY CLERK TO PUBLISH NOTICE INVITING SEALED PROPOSALS FOR SERIES A 1967 WATER REVENUE BONDS IN THE PRINCIPAL AMOUNT OF \$1,500,000.

WHEREAS, a resolution providing for the issuance of water revenue bonds of the City of Redlands in the principal amount of \$1,500,000 has been adopted by the City Council of said City; and
