FREEWAY AGREEMENT

THIS AGREEMENT, made and entered into, in duplicate,
this 15th day of April, 1942, between the STATE OF CALIFORNIA
acting by and through the Department of Public Works, Division of
Highways, hereinafter for convenience referred to as "THE STATE",
and the CITY OF REDLANDS, hereinafter for convenience referred to
as "THE CITY",

W I T N E S S E T H:

WHEREAS, the California Highway Commission on
November 28, 1941, adopted a Resolution declaring the following
section of State Highway Route 26 to be a freeway:

That portion of State Highway Route 26, as same
is shown on the general route map thereof adopted by
the California Highway Commission on November 28, 1941,
which general route map is on file in the office of
the Department of Public Works at Sacramento, California,
between the north right of way line of Fern Avenue and
a point opposite City Reservoir and that portion of
State Highway Route 26, as same is shown on the general
route map thereof adopted by the California Highway
Commission on November 8, 1937, which general route map
is on file in the office of the Department of Public
Works at Sacramento, California, between a point
opposite City Reservoir and the east city limit of the
City of Redlands; and

WHEREAS, this agreement is to cover that portion of
said freeway lying between the north line of Fern Avenue at
Engineer's Station 472+40 and Engineer's Station 543+00; and

WHEREAS, plan maps for such freeway have heretofore
been prepared showing the proposed plan of the State as it
affects City streets;

NOW, THEREFORE, IT IS AGREED:

(1) THE CITY agrees and consents to the construction affect-

1 City streets, all as shown on the plan map hereto attached,
2 marked Exhibit "A" and made a part hereof by this reference.

3 (2) THE STATE in the construction of said freeway will, out
4 of funds available for expenditure on State Highway routes, make
5 such changes affecting City streets in accordance with the said
6 plan attached hereto, or as the same may hereafter be modified by
7 subsequent agreement between the parties hereto.

8 (3) This agreement may be modified at any time by the mutual
9 consent of the parties hereto as may become necessary for the
10 best accomplishment through State and City cooperation of the
11 whole freeway project for the benefit of the people of the State
12 and of the City.

13 IN WITNESS WHEREOF, the parties have hereunto set their
14 hands and seals the day and year first above written.
