

RESOLUTION NO. 7371

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDLANDS DESIGNATING 1240 W. OLIVE AVENUE AS A HISTORIC PROPERTY (HISTORIC AND SCENIC RESOURCE NO. 116)

WHEREAS, Chapter 2.62 of the Redlands Municipal Code establishes rules and regulations governing the designation, preservation and perpetuation of historic and scenic properties; and

WHEREAS, the Historic and Scenic Preservation Commission has held a duly advertised public hearing to consider the designation of the following as a historic property: 1240 W. Olive Avenue, Redlands, California, 92373 (County of San Bernardino Assessor's Parcel No. 0172-071-18); and

WHEREAS, the Historic and Scenic Preservation Commission has nominated the abovementioned property as a historic property in accordance with procedures established in Chapter 2.62 of the Redlands Municipal Code; and

WHEREAS, the City Council of the City of Redlands has held a duly noticed public hearing to consider the recommendation of the Historic and Scenic Preservation Commission;

NOW, THEREFORE, BE IT RESOLVED BY THE City Council of the City of Redlands as follows:

Section 1. The following property, owned by Kathy Behrens and Roger Hardy, is hereby designated as an historic property: 1240 W. Olive Avenue, Redlands, California, 92373 (APN: 0172-071-18) in accordance with the provisions of Section 2.62.170 of the Redlands Municipal Code in that the property is strongly identified with a person or persons who significantly contributed to the culture, history or development of the City, and is a particularly good example of a period or style.

- <u>Section 2.</u> This historic property shall not be altered on the exterior, moved, demolished, subdivided, or otherwise permanently changed on the exterior until a Certificate of Appropriateness has been secured.
- <u>Section 3</u>. The City Clerk of the City of Redlands is hereby directed to cause a certified copy of this Resolution to be recorded with the County Recorder, County of San Bernardino.
- Section 4. The City Council hereby determines that the approval of this Resolution is exempt from review under the California Environmental Quality Act ("CEQA") pursuant to section 15061(b)(3) of the state's CEQA Guidelines because it can be seen with certainty that there is no possibility that approval of this Resolution may have a significant impact on the environment.
