NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Redlands as follows:

1. The following property is hereby designated as an Historic Property:

Gregory Packing House on the south side of Oriental Avenue approximately 75 feet west of Third Street

Legal Description: Property located in the City of Redlands, County of San Bernardino, State of California, described as Lots 2, 4, 6, 8, 10, and 12 of Block D of the Central Townsite Subdivision, as shown in Book 8 of Maps, Page 57, Official Records of said County, along with the vacated portion of a street lying adjacent to the north.

2. The historic property shall not be altered on the exterior, moved, demolished, subdivided or otherwise permanently changed on the exterior until a Certificate of Appropriateness has been secured.
3. A listing of significant design features of the property was determined by the Historic & Scenic Preservation Commission, and these should be preserved in the future.

4. All provisions of Ordinance No. 1954, and any amendments thereto, are in effect now and in the perpetual future.
5. The City Clerk of the City of Redlands is hereby directed to cause a certified copy of this Resolution to be recorded with the County Recorder, County of San Bernardino.
