## CHARLES A. WOOD HOUSE

Those portions of Lots 8, 9, 10 and 11 in Block "B" of Owens Addition, in the City of Redlands, County of San Bernardino, State of California, as per plat recorded in Book 5 of Maps, Page 41, in the Office of the County Recorder of said County, described as follows:
