DESIGNATING AN HISTORIC RESOURCE
HISTORIC RESOURCE NO. 82

WHEREAS, Chapter 2.62 of the Redlands Municipal Code establishes rules and regulations governing the designation, preservation and perpetuation of historical and scenic properties; and

WHEREAS, the Historic and Scenic Preservation Commission has held a duly advertised public hearing to consider designating the following as a historic property:

WHEREAS, the Historic and Scenic Preservation Commission has nominated the above-mentioned property as a historic property in accordance with procedures established in Chapter 2.62 of the Redlands Municipal Code; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Redlands as follows:

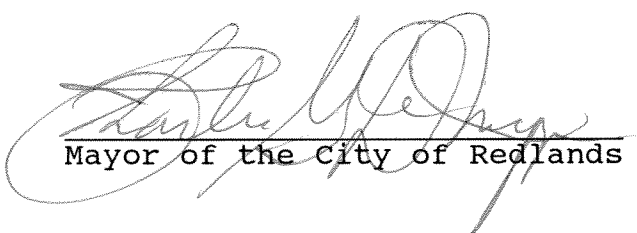
1. The following property is hereby designated as an historic property:

Redlands, California

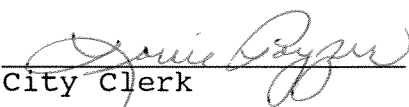
LEGAL DESCRIPTION: Lot 1 of Brock's Subdivision as shown by map on file in Book 13 Page 39 of Maps in the Office of the County Recorder of said County.

2. This historic property shall not be altered on the exterior, moved, demolished, subdivided, or otherwise permanently changed on the exterior until a Certificate of Appropriateness has been secured.
3. All provisions of Chapter 2.62 of the Redlands Municipal Code and any amendments thereto, are in effect now and in the perpetual future.
4. The City Clerk of the City of Redlands is hereby directed to cause a certified copy of this Resolution to be recorded with the County Recorder, County of San Bernardino.

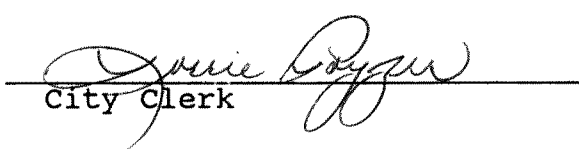
