

RESOLUTION NO. 865

WHEREAS, A Special Municipal Election was held and conducted in the City of Redlands on Tuesday, April 2, 1957;

AND, WHEREAS, it appears that notice of said election was duly and legally given, that voting precincts were properly established, that election officers were appointed and election supplies furnished, and that in all respects said election was held and conducted and the votes cast thereat received and canvassed, and the returns thereof made, determined and declared in time, form and manner as required by the general laws of the State providing for the regulating of Municipal Elections in General Law Cities;

AND, WHEREAS, the City Council of said City met at the Council Chambers thereof on Tuesday, the 9th day of April, 1957, at seven o'clock P.M. to canvass the returns of said election; and whereas the Council finds that as the result of said canvass that the number of votes cast, the Measure voted for, and other matters required by law, to be hereinafter stated, now therefor it is hereby declared,

RESOLVED AND DETERMINED as follows:

That said Special Municipal Election was held and conducted in the City of Redlands on Tuesday, the 2nd day of April, 1957, in time, manner and form as required by law;

That there were seven voting precincts established in said City for the purpose of holding said election, numbered 1 to 7 inclusive, a consolidation of the regular precincts 1 to 40, established for holding State and County Elections;

That the whole number of votes cast in said City of Redlands at said Election was 6,555;

That the measure voted on, the number of votes received for and against in each of said precincts, together with the whole number of votes cast in the entire City are as follows:

"SHALL THE PROPOSED INITIATIVE ORDINANCE TO ESTABLISH A CIVIL SERVICE SYSTEM IN THE CITY OF REDLANDS, CALIFORNIA, BE ADOPTED"
