That the City Council of the City of Redlands does hereby amend Resolution No. 3512 as follows:

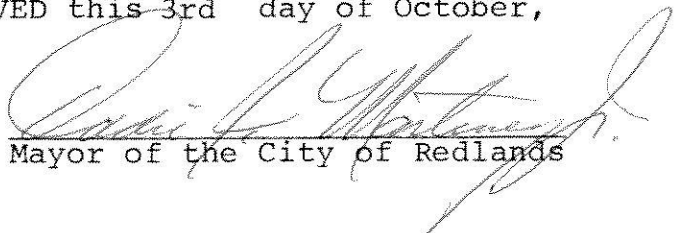

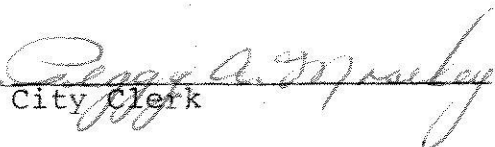
