Public notice is hereby given that on the 14th day of August, 1907, the Board of Trustees of the City of Redlands adopted Resolution of Intention No. 261 to order the following street work to be done, to-wit:

REGO UTION IN

The construction of a public sewer DEWAR III VAR upon Alvarado street along the center line thereof beginning at and connecting with a sewer ten feet northerly from the southerly property line of

Olive avenue and running thence southerly along such center line of said street to a point ten feet northerly from the northerly line of Fern avenue, together with one flush tank with a five-inch Miller-Potter automatic syphon, one manhole, one lamphole and 34 four-inch Y branch pipes, all connected with and as a part of said sewer, and to be placed at such points as shown on the plans therefor

Said sewer is to be constructed of 8-inch vitrified, salt-glazed sewer pipe.

All manholes and flush tanks are to be built of brick and mortar, with & concrete bottom and a cast iron cover, and to be circular in horizontal section, with an inside diameter of five feet on bottom and tapering to two feet inside diameter on top, and flush tank to have an internal height of six feet, and be surfaced on both sides with cement, and manholes to have an external height of six feet and be surfaced on outside with cement. lampholes shall be of six-inch vitrified sewer pipe, with iron cover, and shall be six feet in height.

All sewer pipe, manholes, finst-tanks and lampholes, and all work connected therewith and materials therefor, shall be in accordance with the plans, profiles and specifications therefor on file in the office of the City Engineer, to all of which reference is hereby made.

That the work of constructing said sewer is, in the opinion of said Board, of more than local and ordinary public benefit, and the expense of said work is hereby made chargeable upon the district hereinafter specified. That the exterior boundaries of said district hereby established and the ex-terior boundaries of the lands hereby declared to be benefited by said work and improvement and to be assessed to pay the costs and expenses thereof are described as follows:

Beginning at the northeasterly corner of Lot 3 of Park View Addition of the City of Redlands, thence westerly along the north line of said lot and along the north line of Lot 7 of said addition to the northwesterly corner thereof; thence southerly along the westerly line of the lots that face on the west side of Alvarado street to the southwest corner of Lot 8 of the Buena Vista Tract No. 3; thence easterly along the couth line of said Lox 8 to the northwesterly corner of Lor. 6 of said addition; thence southerly along the westerly line of said lot to the northerly line of Fern avenue; thence easterly along the northerly line of Fern avenue to the southeasterly corner of Lot 2 of the Holden Villa Tract; thence northerly along the easterly line of the lots that face the east side of Alvarado street to the

place of beginning.
