Resolution Ordering Work to be Done No. 273

Resolved, That the board of Trustees of the City of Redlands deem it to be required by the public interest and convenience, and hereby orders that the following street work be done, to-wit:

FIRST:—The construction of a storm water stone drain, for drainage purposes, in, over and through rights of way granted and obtained therefor described as follows, to-wit:

Beginning at a point about 210 feet northwesterly from the northwest corner of the northeast quarter of the southwest quarter of Section One, Township Two, South, Range Three West, S. B. M. (and at the point of beginning thereof as shown upon the plans for said work on file in the office of the City Engineer of said city, to which reference is hereby made), thence extending in a northwesterly direction to the northerly line of Garden street, as shown upon said plans. And beginning again at the southwest corner of Lot four of Block 14 of Map No. 2 of Redlands Heights, according to said Map, thence extending in a westerly direction across the southwest corner of said lot four, and across lots three, two and one of said block 14 to the north line of Cajon street, as shown upon said plans.

SECOND:—The construction of a storm water stone ditch upon Garden

Block 17, to the south side of Summit Avenue, thence to the northeast corner of Lot 12 of Block 18 of said Redlands Heights according to said map; thence along the northerly and north-easterly boundary line of Lot 24 of Block 19, of said Redlands Heights according to said map to the easterly line of Oak Street, thence along the easterly boundary line of Oak Street to a point opposite the northerly line of Campbell Avenue; thence in a straight line to the northeasterly corner of Lot 2, Block 12 of said Redlands Heights according to said map; thence along the southeasterly line of said lot 2, Block 12 of said Redlands Heights, to the northeasterly line of Franklin Avenue, thence along the northeasterly line of Franklin Avenue to the northerly line of Hilton Avenue, thence along the Northerly line of Hilton Avenue to Edgemont Drive, thence along the northerly line of Edgemont Drive to the easterly line of the City of Redlands, thence along the easterly line of said City to the southeast corner thereof, thence west along the south line of said City to the north line of Edgemont Drive, thence along the northerly line of Edgemont Drive to the easterly line of Chapperal Road, thence along the easterly line of Chapperal Road to the south line of Poppy Road, thence along the south line of Poppy Road to Mariposa Drive, thence along the easterly line of Mariposa Drive to the northerly side of Shepherd street, thence along the north side of Shepherd street to Dwight street, thence along the easterly side of Dwight street to the intersection of Dwight street and Ivy street, thence in a direct line to the southeast corner of Hilton Avenue and Cajon street, thence along the easterly side of Cajon street to the place of beginning, excepting therefrom all public streets, avenues and alleys. All of said work shall be done as one job, and awarded as one contract, and but one contract shall be made therefor.

The Redlands Daily Facts, a daily newspaper published and circulated in said city, is hereby designated as the newspaper in which this resolution and notice of said work, inviting sealed proposals, shall be published in the manner and form and by the person required by law.

The City Clerk is hereby directed to publish a notice of said work, inviting sealed proposals or bids for doing said work, and referring to the specifications posted or on file for two days, in the Redlands Daily Facts, a daily newspaper published and circulated in said city, hereby designated for that purpose. Said notice shall require a certified check or a bond, either, as prescribed by law, and for an amount not less than ten per cent of the aggregate of the proposal. He is also directed to post said notice with specifications conspicuously for five days on or near the Council Chamber door.

I hereby certify that the foregoing resolution was duly adopted by the Board of Trustees of the City of Redlands at a regular meeting held on the 16th day of December, 1908.

street to protect the same from overflow and injury as follows, to-wit:

Beginning at and connecting with the storm water drain above described at the northerly line of Garden street, thence extending along the easterly side of Garden street to and connecting with the storm drain above described at the southwest corner of said lot four, and beginning again at and connecting with said storm drain at the north line of Cajon street, thence extending to and connecting with a storm water ditch on the easterly side of Cajon street and all as shown upon said plans therefor on file in said Engineer's office to which reference is hereby made; and in connection therewith and as a part thereof three covers for said ditch, one at Franklin Avenue intersection with Garden Street, one at Hilton Avenue intersection and one at Elizabeth Street intersection and the construction of one lateral storm water stone ditch upon Hilton Avenue beginning at a point in the northeast corner of lot 7 of Redlands Heights, Map No. 1, thence extending in a westerly direction along the north side of Hilton Avenue to and connecting with the proposed Garden Street ditch above described on the easterly side of Garden Street; and in connecting therewith and as a part thereof one cover at the place shown upon said plans therefor.

And in connection with said ditch and said lateral ditch and as a part thereof, there shall be constructed upon said Garden Street and Hilton Avenue on the roadway side thereof reinforced concrete posts, with an iron coil chain connecting each of such posts.

All of said ditch and drain, and lateral ditch to be constructed of stones and cement mortar, and to be of the sizes, dimensions, and location as shown upon said plans, and all of said work described in this resolution shall be constructed according to the plans, profiles, cross sections and specifications therefor on file in said City Engineer's office, to all of which reference is hereby made.

That all of said work above described is, in the opinion of said Board, of more than local and ordinary public benefit, and the expense of said work is hereby made chargeable upon the district hereinafter specified. That the exterior boundaries of the lands hereby declared to be benefited by said work and improvement and to be assessed to pay the costs and expenses thereof, are described, as follows:

Commencing at the most westerly corner of Lot 1 of Block 14 of Map No. 2 of Redlands Heights, thence following the northwesterly and north-easterly side of said Lot 1, and the northerly side of Lots 2 and 3, thence in a direct line to the northwest corner of Lot 12, said Block 14, thence along the northerly line of alley to the northeast corner of Lot 14, Block 17, of said Redlands Heights, according to said Map No. 2, thereof, thence along the west line of Lot 4 of said
