

RESOLUTION NO. 1027

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDLANDS DEDICATING AS A PUBLIC STREET THAT REAL PROPERTY DESCRIBED HEREIN.

WHEREAS, that certain real property owned by the City of Redlands and described herein is necessary for a public use, and a use authorized by law, to wit - a public street; and

WHEREAS, said property is no longer required for any other public use authorized by law;

BE IT HEREBY resolved that this City Council dedicate as a public street that real property located in the City of Redlands, County of San Bernardino, State of California, described as follows:

A portion of Lot 17 of Johnson's Subdivision described as: BEGINNING at a point which is the centerline intersection of Poppy Road and Mariposa Drive; thence south $71^{\circ} 43'$ west $25.90'$; thence south $3^{\circ} 16'$ west $20.71'$, which is on the southwesterly right of way line of Poppy Road, to the true point of beginning;

Thence south $3^{\circ} 16'$ west $113.68'$; thence on a curve of $175'$ radius through an included angle $10^{\circ} 48'$ for a distance of $32.98'$; thence south $7^{\circ} 32'$ east $172.68'$; thence south $61^{\circ} 23'$ west $8.88'$; thence north $16^{\circ} 32'$ west $198.85'$; thence north $13^{\circ} 41'$ east $139.87'$; thence south $71^{\circ} 43'$ east $14.59'$ to the true point of beginning, as per plat recorded in Book 15 of Maps, pages 9 and 10, records of said County.
