NOTICE OF PUBLIC WORK
No. 280

STUART AVENUE OPENING

Public notice is hereby given that on the 16th day of June, 1909, the Board of Trustees of the City of Redlands adopted Resolution of Intention No. 280 to order the following street work to be done, to-wit:

That Stuart avenue be extended and opened and a portion thereof closed as hereinafter described. That the land necessary and convenient to be taken for said improvement in the opening and extension of said Stuart avenue and which said Board intends to take therefor, is situated in the City of Redlands, San Bernardino county, state of California, and described as follows, to-wit:

Beginning at the southeast corner of lot 8 of Terrace Villa subdivision, according to a map thereof of record, in the office of the county Recorder of said county, and running thence east in line with the north line of Stuart avenue (being the south line of lots 8 to 14 inclusive, of said subdivision) produced to the west boundary line of Church street; thence south along the west boundary line of Church street to a point due east of the northeast corner of lot 21 of said subdivision; thence west in line with the north boundary line of lots 15 to 21, inclusive, of said subdivision to a point north of the east line of lot 8 in block "C" of Shorey's subdivision, according to a map of said subdivision of record in said Recorder's office; thence north to the southeast corner of lot 8 in block "B" of said Shorey's subdivision; thence west to the southwest corner of lot 8 in block "A" of said Shorey's subdivision; thence north to the place of beginning.

And the land necessary and convenient to be taken for said improvement in the closing of said Stuart avenue is described as follows:

Beginning at the northeast corner of lot 21 in said Terrace Villa subdivision, thence extending east in direct line with the north boundary line of said lots 15 to 21, both inclusive of said Terrace Villa subdivision to a point north of the northeast corner of lot 8, block "C" of said Shorey's subdivision; thence south to the northeast corner of lot 8, block "C" of said Shorey's subdivision; thence west to the northwest corner of lot 1, block "C" in said Shorey's subdivision; thence north to the place of beginning.

That the exterior boundaries of the district established and the exterior boundaries of the district of land declared to be affected and benefited by said work or improvement, and to be assessed to pay the damages, costs and expense thereof, is described as follows, to-wit:

Commencing at the northwest corner of intersection of Church street and Park avenue; thence west along the north line of Park avenue to intersection of Orange street; thence north along Orange street to northwest corner of lot 18, block "C," Link addition; thence east along the north line of lots 18 and 28 of said block "C," Link addition, to

the northeast corner of lot 28, block "C"; thence in a direct line to southwest corner of lot 1, block "B," of Balcolm's addition, thence along north line of alley in said block "B," of said addition to southeast corner of lot 6, said block "B," of said Balcolm's addition, thence in a direct line east through block "B" of subdivision of part of lot 29, block "77" R. S. B., thence in a direct line to southwest corner of lot 12, block "D," in Best's subdivision; thence along the north line of the alley through said block "D" of Best's subdivision to the southeast corner of lot 7 of said block "D" of said Best's subdivision, thence in a direct line to the southwest corner of lot 6, block "A," Fairbanks' and Wilson's subdivision of lot 30, block 77, R. S. B., thence along south line of lots 6, 5, 4, 3, 2, and 1, of said block "A," of said Fairbanks' and Wilson's subdivision thence in a direct line to the southwest corner of lot 1 of Terrace Villa subdivision; thence along the south line of lots 1, 2, 3, 4, 5, 6, and 7, of said Terrace Villa subdivision; thence in a direct line to Church street, thence south on Church street to point of beginning.

Reference is hereby made to said resolution for further particulars.
