public in-RESOLVED, That the public interest and convenience require, and that it is the intention of the Board of Trustees of the City of Redlands to order the following work to be done, and improvement to be made, to-wit:

That a cement sidewalk five feet the width be constructed on the south

to order the following work to be done, and improvement to be made, to-wit:

That a cement sidewalk five feet in width be constructed on the south side of East Citrus Avenue in said city from and connecting with the existing sidewalk at the west line of the storm water ditch along the G.
