

RESOLUTION NO. 3168

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF REDLANDS AUTHORIZING THE EXECUTION OF A RIGHT-OF-WAY CERTIFICATE PERTAINING TO AN FAU PROJECT KNOWN AS SELECT SYSTEM PROJECT NO. 256 FOR THE MODIFICATION OF TRAFFIC SIGNALS AT THE INTERSECTION OF TEXAS STREET AND REDLANDS BOULEVARD

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF REDLANDS AS FOLLOWS:

WHEREBY, the Mayor of the City of Redlands is hereby authorized and directed to execute on behalf of said City a Right-of-Way certificate pertaining to FAU Project known as Select System Project No. 256 for the modification of traffic signals at the intersection of Texas Street and Redlands Boulevard, a copy of which is attached hereto, marked Exhibit "A", and referred to and made a part hereof as fully as though set forth at length herein.

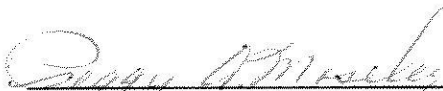

EXHIBIT "A"

NUMBER ONE

RIGHT-OF-WAY CERTIFICATION

The City of Redlands hereby certifies in connection with the right-of-way for an FAU Project known as Select System Project No. 256 that:

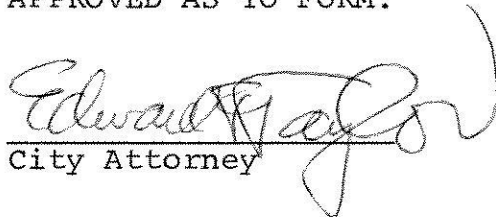
The City of Redlands agrees to hold the State of California harmless from any liability which may result in the event the right-of-way is not clear as certified. If the State is named in a damage
