Resolve, that the public interest and convenience require, and that it is the intention of the Board of Trustees of the City of Redlands, to order the following work to be done and improvements to be made in said City, to-wit:

The construction, for fire protection in said City, of riveted steel and cast iron pipes and installing hydrants and appliances therefor upon the following named streets and avenues in said

City, to wit:

Beginning at and connecting with the Domestic Reservoir near the intersetion of Fifth avenue with Contour street; thence westerly along Fifth avenue to Highland avenue; thence westerly along Highland avenue to New avenue; thence northerly and westerly along New avenue to Reservoir street; thence northerly along Reservoir street to Citrus avenue; thence west along Citrus avenue to First street; thence north along First street to Central avenue; thence east along Central avenue to Lugonia street; thence north along Lugonia street to Stuart avenue; thence east along Stuart avenue to Seventh street.

Also branch lines on Orange street, Fifth street, Sixth street, and Seventh street running between and connect ing with the aforesaid lines on Stuart avenue and Citrus avenue.

Also branch line on Fourth street running between and connecting with the aforesaid lines on Citrus avenue to the north line of Fourth street.

Also branch line on Central avenue running between and connecting with the aforesaid lines on Fourth street and Central avenue at Lugonia street.

Also branch line on Sylveria street and Oriental avenue running from and connecting with the aforesaid line on Central avenue, thence north on Sylveria street to Oriental avenue, thence west on Oriental avenue to and connecting with the aforesaid line on Lugonia street

Also branch line of Third running from and connecting with the aforesaid line on Citrus avenue to and connecting with the aforesaid line on Central avenue.
